Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, regarding transfer of Shri Ram Roop Meena, Deputy Manager, National Insurance Company Limited (NICL), Regional Office, Dehradun.

Shri Ram Roop Meena, Deputy Manager, National Insurance Company Limited (NICL), Regional Office, Dehradun, has submitted a representation dated 31.10.2023, alleging that despite being a Scheduled Tribe (ST) employee, he was transferred to Dehradun upon his promotion, contrary to his request for a posting in Delhi or his hometown of Jaipur. He further claims that general category employees were assigned postings at their preferred locations following promotion. He further pointed out that three vacancies have arisen in Jaipur due to employee superannuation and he requests to be considered for one of these positions.

- NCST vide notice dated 13.11.2023 had referred the matter to Chairman cum Managing Director, National Insurance Company Ltd (NICL), Kolkata for submitting facts and information within 30 days. No reply was received.
- 3. NCST decided to discuss the issue with the authorities and the petitioner on 16.10.2024. Accordingly, a Sitting Notice was sent on 07.10.2024 to the concerned authority and petitioner. Chairman cum Managing Director, NICL deputed GM, NICL and other officials to appear on her behalf. GM, NICL and other officials and petitioner were present in the Sitting. The officials of NICL informed the Commission that the petitioner has been posted in either Delhi or Jaipur for most of his service period. NICL has always considered his requests for posting. In the present case, he had taken a promotion with full understanding that it requires transfer to another place. As per policy, at present, it is not feasible to transfer the petitioner from Dehradun to his choice of posting. The petitioner pointed out his family matters and stated that his family matters could be resolved if he is transferred to nearby his native place or Delhi.
- 4. After hearing both the parties, it was recommended that NICL may consider the petitioner's request on humanitarian grounds. Further, it is also suggested that TA and Special Leave may be reimbursed/granted to the petitioner.
