Minutes of the hearing held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of the Residents of Kondakal Village, Shankerpally Mandal, Ranga Reddy District, Telangana regarding Land Grabbing and Illegal Encroachment of Tribal Lands by Aparna Real Estate Company.

Representation dated 06.09.2024 has received from the Residents of Kondakal Village, Shankerpally Mandal. In the complaint it is mentioned that The residents of Kondakal village, Shankerpally Mandal, Ranga Reddy District, primarily Scheduled Tribe (ST) people, have been cultivating agricultural lands in the region for over seven decades. These lands include those that were assigned to them under the Ceiling Surplus Act after their ancestors' lands were surrendered to the state. Despite being in possession of these lands for generations, they alleged that Aparna Real Estate Company, led by K Vikram Kumar Reddy, who is accused of orchestrating a series of fraudulent land transfers through fake documents. This company is reportedly using its political influence and connections with the TRS government to illegally acquire these tribal lands, often through impersonation and coercive tactics, and selling them at throwaway prices.

- 2. Seeing the gravity of the matter Commission decided to hear the matter with concerned authority and hearings have been held twice. In the matter, last hearing held on 05.11.2024 and Commission recommended that.
- i. The Missing and the complete record of link documents and transfer of ownership from the landlords Smt Subadrabai and Shri Jaggareddy and their son Shri KV Narasimha Reddy during and after land ceiling Act and thereafter from time to time till the recent Dharani entries for the survey numbers of disputed lands of Kondakal, Mokila villages of Rangareddy and Velimala village of Sangareddy District files to be traced.
- ii. The District Collectors of Ranga Reddy and Sangareddy may convene a coordination meeting in 10 days time with Revenue, Police, Panchayat Raj, Irrigation and Endowments Departments and give the detailed instructions to the concerned. The grievance of the petitioners may also be heard at the same
- iii. The details of the 75 farmers who were distributed 113 Acres of land and their names entered into Dharani portal to be submitted along with the transfer of ownership thereafter.
- iv. The Bindover cases on ST farmers may be withdrawn by the authorities and status quo may be maintained.
- v. By the next date of hearing on 09.12.24, there may be the complete clarity on the issue.
- 3. In the hearing, the SDM of Rangareddy District, Telangana, appeared on behalf of the District Collector of Rangareddy. The DCP and ACP of Cyberabad appeared on behalf of the Commissioner of Police, Cyberabad, Telangana. The petitioners were not present before the Commission. The Commissioner of the Endowments Department, Government of Telangana, the District Collector of Sangareddy, Government of Telangana, and the Superintendent of Police, District Sangareddy, Government of Telangana, were absent in the hearing.

i. The RDO who has attended on behalf of the authority has informed that the District Collector has held a detailed discussion with the petitioners and has collected all the evidences relating the land under dispute and will submit a detailed report in 3 weeks time.

ii. The ACP who has attended on behalf of the authority has informed that the CC TV Surveillance is the part and parcel of the Police system and if there are any issues pertaining to the privacy of the villagers, the same will be observed and suitable action will be taken.

4. After hearing, the Commission recommends the following and suggests that -

The District Collectors of Rangareddy and Sangareddy may attend the hearing with Action Taken Report on the Scheduled date of 6.1.2025.
