Minutes of sitting held in the Commission on 02.11.2017 at 2.00P.M. under the Chairmanship of Shri Hari Krishan Damor, Hon'ble Member, NCST in the case of Shri C.M. Meena, Senior Investigator, H. No.RZ-81A, Hans Park, West Sagar Pur, New Delhi regarding filling up backlog vacancies of promotion Senior Investigator to Statistical Investigator Grade.I in the Ministry of Statistics & Implementation, New Delhi.

A representation dated 19.06.2017 received from Shri C.M. Meena, Senior Investigator, H. No.RZ-81A, Hans Park, West Sagar Pur, New Delhi regarding filling up of backlog vacancies for promotion, Senior Investigator to Statistical Investigator Grade-1 in the Ministry of Statistics & Programme Implementation, New Delhi.

2. The matter was taken up with the Ministry of Statistics and Programme Implementation, Sardar Patel Bhawan, New Delhi vide this Commission's letter dated 27/06/2017. In response to this, the Ministry of Statistics & Programme Implementation has intimated to this Commission that a similar issue was raised by the petitioner before Hon'ble High Court of Delhi vide WP No.62/2016. The claim was considered by the Hon'ble High Court on merits and pursuant to the judgment of Hon'ble High Court dated 7th February, 2017, a speaking order was issued by the Hon'ble Court and the same was sent to this Commission vide their O.M. No. dated 11th May, 2017. In this regard, the Ministry of Statistics & Programme Implementation has requested to the Commission to dispose of the complaint of Shri Meena dated 19.06.2017, in the light of the speaking order dated 11th May, 2017. Shri Hari Krishan Damor, Hon'ble Member, NCST has fixed a sitting with the Ministry of Statistics & Programme Implementation for discuss the matter on 02.11.2017 at 4.00 P.M. in person.

Discussion:-

Shri Hari Krishan Damor, Hon'ble Member, NCST asked the petitioner to submit his grievances in response to this Shri Meena stated that he had given a representation for his promotion of backlog vacancy for the year 1997-98 and at that time 3 posts of backlog vacancy were lying vacant in the Department of Statistics. But they had not given him regular promotion to till date. Hon'ble Member (HKD) then asked the officials of Ministry of Statistics & Programme Implementation to give their views in the matter Shri Vivek Shukla, Director, SSS and Shri Subhash Divedi of SSO has stated that the Department of Statistics circulated the vacancy during the month of March and again in July,2000. No eligible ST candidate was available at that time for promotion in the Department. Shri C.M. Meena again objected and stated that in the year 2001 Shri K.K. Chand, Junior Investigator was promoted on regular basis vide Office Order No.A.32012/2/2000-Ad.II dated 11.01.2001 against the vacant post of ST category, since, there were no regular vacancy available in the cadre of Senior Investigator of General category. Hence, Shri C. M. Meena was promoted on Ad-hoc basis along with three others vide Ministry's order dated 11.01 2001. It was observed that Shri Meena was not given regular promotion although there was vacancy available. If Shri Meena was eligible for ad-hoc-promotion, then he should be eligible for regular promotion, if clear vacancy is available. The Department has informed

that vacancy was available but Shri Meena was not eligible. The Commission advised that since, Shri Meena was promoted on ad-hoc basis he should be considered for promotion on regular basis from the date he was promoted on ad-hoc basis as regular vacancy was available. Accordingly, it was advised that a review DPC needs to be held immediately.
