Proceedings of the Sitting taken by Hon'ble Vice-Chairperson, Shri Ravi Thakur, National Commission for Scheduled Tribes on 15/04/2015 in the matter of Shri Chuni Lal Belwa, Commandant, BSF regarding restoration of the seniority and promotion.

In pursuance to the Sitting held in the matter of Shri Chuni Lal Belwa on 05/01/2015 regarding restoration of the seniority in the rank of Deputy Commandant with retrospective effect promotion in the rank of Second-In Command, Commandant of Deputy Inspector General, proceedings were issued vide letter dated 21/01/2015 (**Annexure-II**). Based on the irregularities and short comings noticed in contemporary BSF DPC and observation made vide para 2 (a to h) of proceedings referred above, the Commission advised BSF to take appropriate steps to restore seniority of Shri Chuni Lal Belwa to the rank of Deputy Commandant with retrospective promotions in subsequent ranks in the light of Para 19 and 21 of Minutes of BSF DPC held on 24 November, 1992 which contemplated that 182 officers graded as Very Good at Para 11, Good at Para 12 and Average at Para 19 (name of Shri Chuni Lal Belwa was recommended by the DPC for inclusion in the select name) be brought on the select panel without any over-riding priority to the higher grading.
