A representation from Shri Amit Kumar was received on 03.12.2013 that relaxation in percentage for selecting into Central State Institute of Hotel Management under National Council for Hotel Management and Catering Technology (NCHMCT), Noida.

3. The Hon'ble Vice-chairperson fixed up a Sitting on dated 22.09.2014.

4. An exemption was asked by the Secretary, Ministry of Tourism and sought permission that Deputy Director General (HRD) along with Director, National Council for Hotel Management and Catering Technology (NCHMCT) would appear in the Sitting.



5. Accordingly Deputy Director General appeared before the Commission on 22.09.2014. On discussion Deputy Director General mentioned that as per instructions contained in DoPT O.M. No. 36011/8/84-Estt.(SCT) dated 29.05.1985 "that minimum educational standard, whenever prescribed in the recruitment rules, is to be treated as part of the educational qualification, and since there is no relaxation permitted in favour of Scheduled Castes and Scheduled Tribes with regard to educational qualification, no relaxation is consequently admissible in the matter of educational standards as well. For example, if graduation with 60 per cent marks is specifically provided in the recruitment rules for a particular post, then all the candidates, including the candidates belonging to Scheduled Castes and Scheduled Tribes, have to fulfill this eligibility condition in terms of non-relaxable education qualification in order to be considered for appointment and no special dispensation in respect of any specific category employees either exist or is to be extended in regard to the educational qualification (which is graduation) and the educational standard (which is 60 per cent)".

6. Deputy Director General further said that the Ministry of Tourism is following the above DoPT instructions.

7. The petitioner was also present and was informed of the above instructions. The petitioner was advised that for any other grievances relating to State Government about relaxation/concession they may approach State Government.
