## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Record of Proceedings of the Sitting taken by Shri Bheru Lal Meena, Member, NCST on 18/12/2013 at 1230 Hrs in the Commission with Additional Superintendent of Police, Alwar (Rajasthan) on the representation of Shri Banwari Lal Meena, R/c Village Tehtada, Tehsil Reini District Alwar regarding atrocity and harassment of his family.

- 1. The Sitting was chaired by Shri Bheru Lal Meena, Member, NCST with Additional Superintendent of Police, Alwar (Rajasthan) on 18/12/2013 in the Commisssion on the representation of Shri Banwari Lal Meena, R/o Village Tehtada, Tehsil Reini District Alwar (Rajasthan).
- 2. List of persons who attended the Sitting is attached.
- A Sitting in the matter was earlier held in the Commission on 20/08/2013 with 3. the Additional Sp, Alwar. The Commission had observed that it is a clear case of atrocity upon a member of ST. The minor son of Shri Banwari Lal Meena has become blind and disabled permanently due to action of eye cleave by the opposite party. The Rajasthan Police was requested to take prompt action on the complaint of Shri Banwari Lal/Smt Guddi Devi and file charge sheet against the culprits under the SC/ST (POA) Act, 1989. It was also advised to provide immediate relief to the minor son of Shri Banwari Lal under Rule 12(4) of the Scheduled Castes/Tribes (Prevention of Atrocities) Rules, 1995. The Superintendent of Police, District Alwar was requested to forward action taken report to the Commission within 30 days Commission's vide No.BLM/1/2013/SGGRJ/ATOTH/RU-I dated 30/8/2013. Since action taken report in the matter was not received in the Commission till 02/12/2013, Hon'ble Member NCST, Shri Bheru Lal Meena had called for the Superintendent of Police, District Alwar to discuss the matter in the Commission on 18/12/2013.
- 4. Shri Rajesh Kumar, Addl. SP, Alwar who attended the Sitting submitted that due to engagement in elections duty in the State of Rajasthan, action taken report in the matter could not be forwarded to the Commission. He requested the Commission that action taken report in the matter will be forwarded to the Commission within 15 days.
- 5. Hon ble Member, NCST advised that the Superintendent of Police, District Alwar, Rajasthan may take action on the representation of Shri Banwari Lal Meena, R/o Village, Tehtada Panchayat, Tehsil Rajgadh, District Alwar as advised in the Proceedings of the
