

Sub: Minutes of the Proceedings of the Sitting held under the Chairmanship of Hon'ble Vice Chairman, NCST to discuss the case of Shri Rajpal Meena, employee of North Delhi Municipal Corporation regarding correction in Seniority List.

1. The meeting, under the Chairmanship of Hon'ble Vice Chairman, NCST, to discuss the case of Shri Rajpal Meena took place in the chamber of Hon'ble Vice Chairperson at 1200 noon on 21/11/2014.
2. The list of participants in the meeting is placed at Annexure A.
3. Putting forth his grievance the petitioner said that in the provisional seniority list of the Department, he has been placed at serial no. 99 instead of serial no. 94. He requested for correction in his position in the seniority list.
4. Additional Deputy Commissioner, North, DMC said that the matter was already re-examined and it was found that the seniority list of Junior Engineers (Electrical) was finalized on the basis of panel/merit list received from the DSSSB (Delhi Subordinate Staff Selection Board). He handed over a copy of the result notice of DSSSB. Accordingly, the petitioner was placed in the merit list. Dr. S. K. Yadav further intimated that on receiving the representation from Shri Rajpal Meena, the North DMC had written to DSSSB for clarification in this regard.
5. In the meeting held on 21.11.2014, Dr. A C Verma, Member, DSSSB and Shri A K Kaushal, COE, DSSSB were present.
6. Dr. Verma, Member DSSSB made it clear that the result notice gives the list of candidates, category-wise, provisionally selected and recommended for appointment to the post of JE (Electrical) in Municipal Corporation of Delhi. The list is in the order of merit, category-wise. The indenting organization (in this case, Municipal Corporation of Delhi) has to make their own order of merit according to their rank/marks obtained by the candidates.
7. Dr. S K Yadav said that he will however seek written clarification from DSSSB on this point and recast and refill the available posts of JE (Electrical) in North DMC and consider the candidature of Shri Rajpal Meena on merit as per recruitment rules and mode of selection and marks obtained by him.
8. Hon'ble Vice Chairperson accepted the suggestion and advised both North DMC & DSSSB officers to take needful steps on priority basis and bestow the petitioner, his due benefits like seniority promotion etc. at the earliest.
9. The meeting ended with vote of thanks to the Chair.
