Subj: Sitting with concerned Deputy Commissioner of Delhi Police regarding incidents of atrocities, harassment and exploitation with STs regularly being reported in the media.

Sir,

I am directed to invite your attention to the Sittings of the Commission held on 4/10/2013 and 10/10/2013 and a D.O. letter of Secretary, NCST No. Secy/NCST/VK/01 dated 17/10/2013 bringing out the issues in your notice on the subject. It is observed that appropriate response in the matter has not been received from your office.

2. The incidents of atrocities, harassment and exploitation has regularly been reported in the media and came to the notice of this Commission. A list of reported cases of atrocities committed on STs during the period 2012 till date involving the cases of domestic maids from the State of Jharkhand and other States is enclosed.

3. The Commission has noted that the cases against the tribal community through persuasive migration particularly women doing household jobs/domestic servants and their exploitation by the middlemen and the placement agency etc. has been increased proportionately in recent times as came in light through media, representation received in the Commission and Parliament Questions.

4. The Commission is seriously concerned about the Scheduled Tribes girls and women engaged as maids/domestic servants, workers are being exploited by the employees and the middlemen/placement agencies. The Delhi Police is need to take preventive, punitive and precautionary steps to safeguard the ST girls and women against such exploitation
