Proceedings of the Sitting taken by Shri Ravi Thakur, Hon'ble Vice Chairperson, NCST on 24.12.2014 in the matter of Shri Rajesh S. Vanzare, EX-JMGS-1, State Bank of India regarding reinstatement.


Date of Sitting : 24.12.2014.

Lists of the officers present: (Annex I)

Shri Rajesh S. Vanzare, Ex-JMGS-1 represented to NCST on 05.03.2014 that he was promoted as JMGS-1 officer and transferred to Varga Branch, Gadchiroli area. He was directed to report to the Assistant General Manager (Admn.), Nagpur without availing joining time vide SBI order dated 21.11.2009. His request for a posting to a Branch near the railway line, so as to reach out to his family in Mumbai, was not agreed to by the SBI authorities. He has alleged that he was removed from service by the SBI.

The matter was taken up with SBI authorities. SBI intimated vide letter dated 07.08.2014.

- (1) Shri. Rajesh S Vanzare was promoted to Junior Management Grade Scale-I (JMGS-I) from Mumbai Module to their Bank where he was working at clerical cadre before promotion.
- (2) On his promotion to JMGS I, he was transferred to Nagpur Module as per the transfer Policy of the Bank.

- (3) The said official reported to Nagpur Module on 24.11.2009.
- (4) The petitioner after reporting to Administrative Office, Nagpur has remained unauthorized absent from 26.11.2009 to 03.02.2010.
- (5) Considering persistent absence for the enquiry, it was decided to refer him to Bank's Senior Medical Officer at Local Head Office, Mumbai for medical fitness as the official was residing in Mumbai.
- (6) He failed to appear before Bank's Senior Medical Officer also.
- (7) Even though enquiry was set up he did not appear or sent any representative. The reply of the Bank dated 7.8.2014 was informed to the petitioner.

The Commission desired to discuss the matter with Chairman, SBI on 24.12.2014. Accordingly notice for the sitting was sent to Chairman, SBI.

Chairman, SBI vide letter 20.12.2014 sought exemption due to prior official engagement on 24.12.2014 On behalf of Charman, SBI, G.M, LHO (Mumbai) appeared before the Commission on 24.12.2014. G.M, SBI informed that Shri Rajesh S Vanzare was transferred and he was unauthorized absent from 26.11.2009 to 3.2.2010 and joined duties on 4.02.2010 and again remained absent without any intimation to the bank. Sh Rajesh S Vanzare did not appear in the enquiry nor sent any intimation in this regard to the bank. The bank had proceeded with the judiciary enquiry, following the rules and procedure. The petitioner was also heard.

The Commission noted that petitioner has not filed any appeal to the Bank on his removal from service. Commission discussed and the advised the bank that looking into his medical & family circumstances, Shri Rajesh S Vanzare may prefer an Appeal justifying his grievances on removal from services.
