While reviewing status of representation of STs in respect of various categories of teaching and non-teaching staff in Central and State Universities, the Commission has noted with concern that many Universities are following rosters department-wise with no grouping of posts as stipulated vide DoPT O.M. dated 02/07/1997. Thus, the instructions issued by the DoPT with regard to grouping of posts are not being followed by most of the Universities/teaching institutions. This has also resulted in continued lower representation of the STs in these institutions and denial of benefits available to STs in service.
