At the outset, Dr. Rameshwar Oraon, Hon'ble Chairperson welcomed

the team of NHPC headed by Shri R. S. Mina, Director (Personnel).

Shri R. S. Mina, Director (Personnel) expressed thanks to the Hon'ble

Chairperson, National Commission for Scheduled Tribes for choosing NHPC

for the above-mentioned Review.

1. Thereafter Shri R.S.Mina gave a power-point presentation on the

implementation of Reservation Policy and CSR Schemes for the

welfare of Scheduled Tribes.

- 2. Hon'ble Chairperson desired to know the cases of de-reservation in NHPC. In this regard, Director (Personnel) intimated that there is no case of de-reservation in NHPC. However, Hon'ble Chairperson advised to insert a clause in Recruitment & Promotion Rules that if a post is de-reserved in higher group, equivalent number of reserved post would be increased in lower group.
- 3. Various kinds of relaxations & concessions given to the ST Candidates in the recruitment & promotion in NHPC were explained by Director (Personnel) to the Hon'ble Commission. Hon'ble Chairperson appreciated the rising trend in overall representation of STs in the company. Hon'ble Chairperson, however, advised NHPC to achieve the prescribed percentage of 7.5% of STs representation through Special Recruitment Drive in a time-bound manner keeping in view the lower representation of STs i.e. 5.88% in overall staff-strength in NHPC.
- 4. It was further apprised by NHPC that 11 numbers of posts of Trainee Officer (Finance) could not be filled up due to non-availability / non joining of ST candidates even after continuous 06 Special Recruitment Drives made since 2008. Director (Personnel) assured that the above vacancies shall not be de-reserved and efforts shall be made to fill up these vacancies through more Special Recruitment Drives. It was also advised that possibility

- 5. Executive Director (Corporate Social Responsibility) submitted that NHPC is undertaking various activities under CSR in the fields of Education & Skill Development, Health & Sanitation, Rural Development, Environment & Sustainability for overall development of the people living around their projects, including people of the Scheduled Tribes. Besides, under Swachh Bharat Abhiyan, large number of toilets have been constructed near NHPC Projects/ Power Stations situated in tribal areas. Maintenance contracts for these toilets have also been awarded by the company. The Joint Secretary, NCST suggested to explore the possibilities of construction of modern waterless toilets as developed by DRDO, which are almost maintenance free. NHPC ensured that they would be in touch with DRDO in this regard.
- 6. The Hon'ble Chairperson advised to take due care while awarding scholarships to students so that double payments of scholarships from Central/State Government and from NHPC to students under various schemes be avoided. He further advised that basis for granting scholarships should be income of parents and performance of students. The Chairperson, NCST also advised that the company should strive hard and ensure that scholarships, cost

forest areas.

7. Deputy Secretary, NCST pointed out that the funds allocated for

CSR activities were utilized partly till the Financial Year 2012-13. It

was apprised by ED (CSR) that unspent funds allotted for CSR

activities were carry-forwarded and utilized in the subsequent years.

An amount of Rs. 64.92 Crores has been allocated for the year

2015-16 out of which Rs. 63.49 Crores (97.79%) has been spent on

CSR activities till 15.03.2016.

8. The Hon'ble Chairperson appreciated the initiative taken by NHPC

for the Cultural activities on Statehood Day of Arunachal Pradesh

and further advised to undertake activities under CSR for promoting

tribal languages/traditions/customs also.

9. Secretary, NCST desired to know the NHPC policy for taking up

various activities under CSR, with particular reference to STs. He

also wanted to know the Policy of NHPC for having independent

impact evaluation of CSR activities taken up by the NHPC. NHPC

assured to provide their policies quickly.

10 Various suggestions and queries made by the Officers of the

NCST were endorsed by the Hon'ble Chairperson, NCST.

11 The meeting ended with vote of thanks to the Chair.
