Sub: Review and Monitoring of constitutional safeguards and developmental schemes/programmes being run by the welfare of Scheduled Tribes in the District of Chittoor(AP) by the National Commission for Scheduled Tribes.
Sir,

The National Commission for Scheduled Tribes (NCST) set up under Article 338A of the Constitution is vested with responsibility inter-alia, to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The Commission is required to present to the President annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

2. Accordingly, the National Commission for Scheduled Tribes has decided to review the implementation of constitutional safeguards and development programmes/schemes being run for the welfare of Scheduled Tribes in the District of Chittoor (AP) at Tirupathi with District Collector, Superintendent of Police and Senior District Level Officers. During the review, the Commission will focus implementation of PESA, Forest Rights Act including community forest rights and other issues for which presentation is to be made by District Administration. The review meeting will likely be held in the first week of August, 2019. The detailed tour programme will be intimated separately.

3. The Commission has evolved a questionnaire for review and a copy of which is enclosed for furnishing replies/information by the District Administration. The questionnaire can also be down loaded from NCST Website <http://ncst.nic.in/content/questionnaire-review-download>. The replies to various issues covered under the questionnaire will form the basis for review meeting in the District. It is requested that the information w.r.t. the questionnaire may please be prepared and furnished to this Commission in hard copy as well as in soft copy to js@ncst.nic.in and bansal.yk@ncst.nic.in by 25th July, 2019 positively.

4. It is also requested that necessary arrangements for holding of Review meeting may be made accordingly and the presence of all Senior Officers of various Departments of the Districts be ensured at the time of Review meeting.

5. This may be treated as most urgent.
