The Administrative Reforms Department, Government of Jharkhand vide letter No. 7/ -19-05/2007 -2098 dated 02.3.2012 had recommended for inclusion of eight communities namely 'Bhogta'(भोजता), 'Deshwari' (वैद्यादारी) , Ganjhu' (अस्त्री) , 'Dautalbandi' (Dwalbandi') [दिवित्र कर्ने) (अल्बे) Patbandi (ब्रह्मक्री), 'Raut' (संख्या), 'Maajhia' (आदिग्या) and 'Khairi' ('Keri') (दिविद्यो) अynonyms of 'Kharwar'(खरवार) community in the list of Scheduled Tribes in Jharkhand State. As per the approved modalities, the recommendation alongwith justification furnished by the Government of Jharkhand was referred to the Registrar General of India for comments/views. The Registrar General of India, vide their D.O. letter No. 8/1/2012-SS (Jharkhand) dated 18-12-2013 has furnished its comments (copy enclosed).
