# Comments of ORGI on the Chhattisgarh State Government's proposal for inclusion of Binjhia community in the Scheduled Tribes list.

In the year 2004 this office had examined the proposal for inclusion of Binjhia community in the STs list as synonym of Binjhwar notified as ST at entry no. 11 in the STs list. On the basis of available published ethnographic literatures this office vide its D.O.No. 8/1/2005-SS (Chhattisgarh) dated 14.12.2005 conveyed that 'the information indicate that Binjhia are now separated from Binjhwar and maintaining an independent ethnic entity. Both Binjhia and Binjhwar are Scheduled Tribes in some of the states of India. In Bihar, Jharkhand and Orissa they are notified by the term Binjhia and in Madhya Pradesh and Maharashtra they are notified by the term Binjhwar. But in no state both the terms are notified simultaneously as sub entry of the other'. Since both Binjhia and Binjhwar are endogamous group having distinct entitity, this office did not support the proposal for inclusion of Binjhia as synonym of Binjhwar in the STs list of Chhattisgarh.

2. In compliance to above comments of this office the State Government has now recommended for the inclusion of Binjhia in the STs list as an independent entry. An ethnographic report based on the field study conducted by the Tribal Research & Training Institute Raipur in five districts namely Raipur, Janjgir-Chanpa, Surguja, Koria and Korba has been furnished in support of the present proposal.

#### Justification given in the Ethnographic Report:

The Study Report states that Binjhias are mainly concentrated in Scheduled areas of Raipur, Janjgir-Chanpa, Surguja, Korba and Korea districts of Chhattisgarh State with the other STs of the state namely Binjhwar, Gond, Agariya, Oraon and Kanwar etc. They speak Chhattisgarhi, Surgujia and Sadri languages. The traditional occupation of Binjhia has been cultivation, agriculture labour besides collection of forest produce, fishing and rearing of cattle.

2. The Binjhias have totemistic exogamous clan system. Many of their clan are named after plants and animals and member of septs refrain from killing or destroying the animals or plants after which it is named. The name of the septs are generally Chhattisgarhi words e.g. Gourchiya (honey bee), Bageria (tiger), Bhandil (ox), Kunwar(bird) though a few are in Gondi which are exogamous in nature. The community worship soul, spirits and natural objects. They have their own pantheon and folk deities. They have their community priest who officiates in various socio religious rituals.

- 3. Like many other tribal communities, the custom of bride price is prevalent among Binjhias. They have their own folk dances and songs for fair, festivals and life cycle rituals.
- The Report further mentions that the caste name Binjhia has been 4. written in the Revenue and Government records. But the said community even being one of the divisions of Binjhwar a ST in Chhattisgarh are deprived of the constitutional safeguards which they availed as ST prior to verdict of Ourt in 2001(page: 103). The said Judgement (AIR the Hon'b on'ble Supreme Court regarding Order issued under 2001 SC ( Article 34 he Constitution reads as 'The Scheduled Tribes Order must be t is not even permissible to say that a tribe, sub-tribe, I tribe or tribal community is synonymous to the one part of or grown mentioned in the Scheduled Tribes Order if they are not so specifically mentioned in it'. The Notification issued, in the Provision (1) of the Article 342 specifically mentions that there is no right to State Govt., Court or Tribunals or any other Authority to change, modification, or correction in the list of STs.

### Comments of ORGI:

Earlier Census Report (Census of India, 1911, Vol.X, Central Provinces and Berar Pt-I, Report, P.221) states that 'the Binjhias are offshoot of the Binjhwar. All of these now sometimes regard themselves as separate castes'. The Binjia or Binjhia has been classified under Binjhwar by Shoobert, W.H.(Census of India, 1931, Central Provinces & Berar, Pt-I Report, page; 375). Nelson, A.E (in the Central Provinces District Gazetteers, Vol. A. Raipur; 1909, P. 107) has written that in Raipur Binjhwars have four subdivisions, the Binjhwar proper, the Sonjharas or Gold washers, the Birjhias and the Binjhias. The ethnographic volume The Tribes and Castes of the Central Provinces of India, Vol.II, 1975 rpt.page;331 has also described Binjhia as one of the said four subdivisions of Binjhwar tribe. Contemporary ethnographic information indicate that now Binjhwars have two endogamous divisions, namely, Binjhwar proper and Sonvaha Binjhwar (K.S. Singh, 1998, India's Communities, PP. 498-500). Singh, in his report, has treated 'Binjiya' as a separate entity and stated them as an endogamous group.

- 2. The enclosed Ethnographic Report suggests that like their neighbouring tribal communities Binjhias have distinct and specific culture in their entire socio religious and economic organisation. They are foragers who collect forest produces, trap small games besides working as agriculture labour and cultivators. Prevalence of an elaborate totemistic clan system, custom of bride price during marriage, worship of spirits, soul and animistic form of religion are the tribal characteristics which place Binjhias akin to the STs of the State.
- 3. The above information given in the published dependable ethnographic volumes convey that Binjhia/Binjias is one of the divisions of Binjhwar already notified as ST in Chhattisgarh. Binjhias is a separate distinct endogamous entity. Being one of the divisions of Binjhwar, they also possess specific and distinct tribal traits. Binjhia is a Scheduled Tribe in the neighbouring states of Jharkhand, Bihar and Odisha. In 2005 this office although did not agree for the inclusion of Binjhia as a synonym/ sub entry of Binjhwar in the STs list of Chhattisgarh but accepted Binjhia as an endogamous tribe distinct from Binjhwar. Binjhia fulfils the requisite criteria laid down for identification of community as a Scheduled Tribe.

In view of the above this office supports the Chhattisgarh State \Government's proposal for inclusion of Binjhia community as an independent entry in the list of Scheduled Tribes of the State.
