Subject: - Draft Note for the Cabinet on National Policy for Domestic Workers – regarding.

The Ministry of Labour & Employment set up a Task Force to evolve policy framework for domestic workers in the context of regulatory mechanism and providing social security. The Task Force drafted a National Policy for Domestic Workers. The Draft Policy was circulated to the Ministries/Departments of Central Government through a Draft Cabinet Note seeking their views/comments thereon vide this Ministry's O.M of even no. dated 30.12.2011. Subsequently, the Committee of Secretaries (CoS) was constituted to consider/examine this Policy. The Committee recommended adoption of the National Policy with certain observations.

2. Pursuant to the recommendations of CoS, this Ministry has prepared a revised Cabinet Note for seeking approval of the Cabinet for adopting National Policy for Domestic Workers. A copy of the revised Draft Cabinet Note alongwith the Policy is enclosed.
