The Ministry of Tribal Affairs in the letter No. 12016/3/2012-C&LM-I dated 24/02/2014 has forwarded a proposal for Inclusion of 'Saura', Sahara', 'Soura', 'Saunra'/ 'Saonra', 'Saora', as synonyms of 'Sawar' and 'Sawara' appearing as ST at Sl. No. 41 in the list of STs of Chhattisgarh. Pursuant to the discussion held in 53rd meeting of the Commission,

2. It was brought to the notice of the Commission that the Commission could not visit the State being pre-occupied with other important issues and also with similar issues involved in the Task Force Committee which later converted into draft Cabinet Note by MoTA. The Commission discussed the matter and decided in the case that the Commission will visit Raipur in the month of February 2015 and after that it will take a view on the case.
