

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Moti Lal Meena, Senior Superintendent (HR), Regional HQ (NR), Operations Office, NATS Building regarding non-promotion by AAI even despite being called for interview.

**Date of the Sitting: 09/04/2025, 12:00 Noon**

The petitioner, Shri Moti Lal Meena, Senior Superintendent (HR), Regional HQ (NR), Operations Office, NATS Building, New Delhi, vide his petition dated 20.02.2024 has submitted that he had successfully cleared the departmental written examination for the post of Junior Executive (HR) conducted by AAI, and was called for interview scheduled on 23.01.2013 at the Corporate HQ, New Delhi. Despite attending the interview venue as per schedule, his interview was not conducted and he was merely told that he would be given weightage in future interviews. Subsequently, despite multiple representations to various authorities from February 2023 to February 2024, no action was taken. In response to some of his letters, AAI informed that the departmental recruitment was cancelled due to administrative reasons and that he had been found devoid of merit without even being interviewed. Moreover, it was conveyed that no further representations from him would be entertained. He contends that the selection result was declared and appointments made with retrospective effect from 01.04.2014, even though the matter was claimed to be sub judice. He has alleged that the decision to exclude him from the interview and final selection has adversely affected his career and has requested the Commission to ensure his inclusion in the selection process and grant of backdated promotion benefits in parity with other successful candidates.

2. NCST vide Notice dated 16.01.2025 had referred the matter to Chairman, Airports Authority of India for furnishing the facts and comments within 30 days. The reply was not received, hence, the NCST decided to discuss the issue with the authority and the petitioner on 09.04.2025. Accordingly, a Sitting Notice was sent on 27.03.2025.

3. In the sitting, the Executive Director (HR), AAI was present on behalf of Chairman, AAI along with other officers. The petitioner was also present. The ED (HR) informed that the petitioner was not holding the required degree for the post at that time and hence after document verification, he was found ineligible and not allowed to sit for the interview. The petitioner claimed that he was eligible and another person with similar degree/ diploma was interviewed and passed successfully while he was stopped.

4. After hearing both the sides, the following recommendations were made and action taken report to be submitted within 30 days from the receipt of the minutes. Thereafter, NCST will decide further course of action in the matter –

- The petitioner is advised to submit the details of the employees who has similar qualification and selected by the AAI
- The list of selected candidates (with qualification (mentioning degree/ diploma) for the said post may be furnished to NCST.
