## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/DEV-4378/TS/265/2025-RO-BHUV/RU-III

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banoth Mangilal Naik, Telangana State President, Bharath Gore Sabha, Mahabubabad, Telangana regarding non-filling up of backlog vacancies in AYUSH Department of Telangana.

Date of the Sitting: 08/04/2025, 05:00PM Participants in the Sitting: As per Annexure

Shri Banoth Mangilal Naik, Telangana State President, Bharath Gore Sabha, Mahabubabad, Telangana, vide his representation dated 18.01.2025 has stated that despite the availability of vacancies for Unani Medical Officers in the AYUSH Department of Telangana and eligible SC/ST candidates the backlog vacancies have not been notified resulting in the loss of career opportunities for ST candidates.

- 2. NCST vide notice dated 17.02.2025 sought facts and comments from the Director, Department of Ayush, Ministry of Health and Family Welfare, Govt. of Telangana within 30 days from receipt of the notice.
- 3. The Director, Department of AYUSH, Telangana, vide letter no. 333/B2/Unani/2019 dated 17.03.2025 has informed that as per Government approval the department has issued a Notification No.01/U/2019 dated 30.11.2019 for filling (18) SC/ST backlog vacancies, out of which 13 posts were filled in January 2020, while 5 vacancies were carried forward due to non-availability of eligible candidates. Subsequently, in line with further approvals, an indent was submitted to the Telangana State Medical Services Recruitment Board for filling up 69 vacant posts of Medical Officers (Unani), including 5 SC/ST backlog vacancies. The Recruitment Board issued Notification No.1/2023 dated 13.07.2023 and the recruitment process is in its final stage, with the provisional selection list yet to be issued. The department has assured that necessary steps are being taken to fill SC/ST backlog vacancies. This was sent to the petitioner vide NCST letter dated 01.04.2025 for information.
- NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025.
   Accordingly, a Sitting Notice was sent on 26.03.2025.
- 5. The Director, Department of Ayush, Govt. of Telangana, Secunderabad vide letter no. 333/B2/Unani/2019 dated 6.4.2025 has informed that due to pre-occupied schedule unable to attend the sitting and deputed Addl. Director, (Unani) to appeared in the sitting. A detailed report related to the case has also been submitted in the sitting vide its letter no. 333/B2/Unani/2019 dated 6.4.2025.
- 6. In the sitting, Addl. Director (Unani), D/o Ayush, Govt. of Telangana along with other officers were present. The petitioner joined via Phone Call.
- 7. After discussion with the, Addl. Director (Unani), D/o Ayush, Govt. of Telangana and petitioner (joined via phone call), the following recommendations were made and action taken report may be submitted to NCST within 30 days from receipt of the minutes.
- a. The Department of AYUSH, State of Telangana may coordinate with the Medical Recruitment Board for completion of the recruitment of ST backlog vacancies.
