Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri V Bujji, Sarpanch, Bhukya Ram Thanda, Kesamudram Mandal, Mahabubabad District regarding non-issuance of Pattas to STs who have been in possession of land for a long time.

**Date of the Sitting: 08/04/2025, 02:40 PM**  
**Participants in the Sitting: As per Annexure**

Shri V Bujji, Sarpanch, Bhukya Ram Thanda, Kesamudram Mandal, Mahabubabad District, vide his petition dated NIL, has stated that though ST families belonging to the BPL category have been cultivating 74 acres of Government land in Survey Number 399/1 and 50 acres of forest land for the last 25-30 years. The lands have not been surveyed and pattas have not been provided to ST families.

2. NCST vide notice dated 01.01.2025 sought facts and comments from Collector and District Magistrate, Mahabubabad within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 08.04.2025. Accordingly, a Sitting Notice was sent on 26.03.2025.

3. In the sitting, the Collector and District Magistrate, Mahabubabad and petitioners were present. The Collector and District Magistrate, Mahabubabad informed that the matter relates with the Forest Department.

4. The petitioner has informed that in Kesamudram though the farmers have been in cultivation they have not been provided the IFR title deeds under ROFR as the said land is under Forest Revenue Dispute.

5. After discussion with the Collector and District Magistrate, Mahabubabad and petitioners, the following recommendations were made and action taken report may be furnished within 30 days from receipt of the minutes.

- Forest survey to be done and Forest Department may provide the compartment number and where ever the clarity of Forest land emerges the IFR may be provided immediately by conducting the Gram sabha if it is proved to be under occupation and cultivated as on cut off date of FRA.
- The remaining disputed land may be informed to the Revenue Department.
- A joint survey may be conducted by the Forest and Revenue Departments for further necessary action.
