

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Dr. Kalyan Nayak, BJP ST Morcha State President, Nampally, Hyderabad regarding various problems faced by the tribal students, professors, teaching and non-teaching staff in Osmania University.

Dr. Kalyan Nayak, State President, BJP ST Morcha, Hyderabad (Telangana) vide his petition dated 09.12.2024 has raised serious concerns regarding the neglect of ST interests in Osmania University, Hyderabad. He has highlighted that ST students and staff continue to face discrimination and lack of support in the University. The issues are non-implementation of backlog recruitment, lack of hostel facilities, failure to promote ST employees, violation of reservation norms, lack of recruitment in various departments, no remedial or coaching support for ST students and misallocation of RUSA and funds released by Ministry of Social Justice for SC/ST Students. He has also alleged land encroachment on university premises and demanded an immediate survey.

2. NCST vide notice dated 14.02.2025 sought facts and comments from the Registrar, Osmania University, Hyderabad within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 24.05.2025. Accordingly, a Sitting Notice was sent on 19.05.2025.

3. In the sitting, Registrar and OSD to VC of Osmania University, Hyderabad and petitioner were present.

4. After hearing to the petitioner and authorities the following recommendations.

a. The backlog vacancies may be filled first and then the General vacancies for the maximum benefit of the reserved sections.

b. Rule of Reservation may be followed both in teaching and non teaching staff recruitments.

c. The NET/GPAT/GATE and Civil services coaching facilities may be commenced in the University campus.


d. The District Collector Medchal Malkajgiri may furnish the details of land owned by the Osmania University, the current encroachments, survey and the boundary details.

e. The University administration may furnish the details of land leased to private parties, petrol bunks, buildings on the campus rented to the private persons and the revenue accrued from the same.

f. The Registrar, OU may submit the budget received by the Osmania University from the State Government and Government of India in the last 10 years and the expenditure details.

g. The details of the RUSA funds allocated to the Osmania University till now and the expenditure details may be furnished to NCST.



5. The action taken report(ATR) may be submitted within 30 days from the date of receipt of minutes.
