- 2. NCST vide notice dated 26.12.2024 sought facts and comments from the Principal Secretary, Higher Education Dept, Government of Telangana within 30 days from receipt of the Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 09.04.2025. The Higher Education (CE) Department, Govt. of Accordingly, a Sitting Notice was sent on 27.03.2025. The Higher Education (CE) Department, Govt. of Telangana vide letter dated 7.4.2025 has deputed CCE &CTE, Hyderabad to attend the sitting.
- In the sitting, Commissioner Technical Education, Govt of Telangana was present. But the petitioner was absent.
- 4. After discussion with the concerned authority, the following recommendations were made and action taken thereon may be submitted within 30 days from the receipt of the minutes.
- 5. As per the discussion it is inferred that the petition relates to a common misunderstanding and miscommunication and not related to discrimination as claimed by the petitioner. It is suggested that the administration may foster healthy relations between the faculty as they would be the immediate role models to the youth they would be teaching and could help in aiding healthy academic atmosphere.
- Hence no action is warranted on part of NCST and the case is closed.
