Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Turram Venkatesh and others regarding seizure of their ancestral land by Forest Department.

**Date of the Sitting: 19/09/2025, 04:00 PM**

Shri Turram Venkatesh, Smt. Charugulla Usha, and Shri Naradala Nageswar Rao, all legal heirs of ST farmers, vide their petition dated 14.05.2025, have stated that the Forest Settlement Officer, Khammam had taken possession of their ancestral land measuring 21.34 acres in Survey Nos. 625, 626, 627, and 712 in Aknepally Village, Dammamet Mandal, during 1970, which was later merged into forest land. Although Gazette Notification No. 23-B dated 12.06.1986 and Khammam District Gazette No. 32 dated 14.06.1989 provided for allotment of alternate land to their ancestors, the same has not been implemented till date. Despite repeated representations over the years, no relief has been granted, and the petitioners, now in a financially weak condition, request allocation of alternate land or return of their original land from the Forest Department.

2. The Commission issued notice to the Collector & District Magistrate, Bhadradi Kothagduem, District Forest Officer, Bhadradi Kothagduem and Chief Commissioner of Land Authority, Hyderabad, Telangana vide NCST letter dated 14.08.2025 seeking facts and comments within 30 days.

3. Since reply was not received hence the Commission has decided to discuss the issue with the authority and the petitioner on 19.09.2025. Accordingly, a Sitting Notice was sent on 12.09.2025.


4. The Project officer, ITDA Bhadrachalam has attended the hearing on behalf of the District Collector. The petitioner has attended the hearing.

5. The petitioner has informed that their ancestral land admeasuring 21.34 acres in Survey Numbers 625, 626, 627 and 712 in Aknepally Village, Dammamet mandal during 1970 was merged into the forest land. Although Gazette notification No. 23-B Dated 12.6.1986 and Khammam District Gazette No. 32 Dated 14.6.89 provided for allotment of alternate land to their ancestors, the same has not been implemented till date. Their request for allocation of alternate land is not realized. It is further informed that the Forest Department has not made use of the land that is acquired from them merged into the Forest.

6. The authority has informed that though the alternate land is allocated and handed over, it was encroached and some of the WPs were filed by either sides in the Court. Hence the same could not be materialized to restore possession to rightful beneficiaries, however partial possession of 8 acres has been given as per High Courts directions.

7. After hearing to the authority and petitioner the following recommendations were made and ATR may be submitted in 30 days from the receipt of the minutes.

- a. The commission took serious note on the long pending issue since last 40 years.
- b. An alternate dispute free land may be immediately allocated to the petitioners in 30 days time as they are dependent on it for their livelihood.
- c. The option of possibility of allocating the unused sericulture land may be explored as per the request of the petitioner.
