

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Bhukya Ramesh (Contract worker, TS GENCO KTPP, Chelpur (Bhupalapalli)) regarding regularization of service by TG GENCO.

Shri Bhukya Ramesh (Contract worker, TS GENCO KTPP, Chelpur (Bhupalapalli)), vide his petition dated 23.12.2024 has stated that he has been working as a contract worker since 2012 and was engaged prior to the cut-off date of 04.12.2016, holding agreements for the work; he was later set aside as "jobwork" and approached the High Court, which issued directions and referred the matter to a committee but the promised implementation did not follow. He alleges that fresh recruitments/regularisation exercises later admitted many candidates — notably on 19.10.2018 (about 54 persons) and another exercise on 09.07.2017 — while he remained without relief despite making representations repeatedly. He requests compassionate consideration and regularisation so he can support his family.

2. NCST vide notice dated 01.01.2025 sought facts and comments from CMD, TG GENCO within 30 days.

3. Reply was not received hence the Commission decided to discuss the issue with the authority and the petitioner on 19.09.2025. Accordingly, a Sitting Notice was sent on 12.09.2025.

4. The Authority CMD, GENCO was present along with JS. The petitioner joined the hearing over phone.

5. The authority has informed that the petitioner is not figured in the 954 outsourced personnel list of KTPP(878 considered list and 76 not considered list) whose details are uploaded in the OPIS, and their details were examined by the committee constituted to verify and scrutinize the biodata particulars for absorption as per guidelines. Further it is informed that he is one of the petitioner in WP No 35102/2018 filed by Smt.M.Kavitha and 10 others and the same is pending before the Hon'ble High Court.

6. After hearing to the petitioner and authority the following recommendations were made and ATR may be submitted in 30 days of time.

- a. Agency area Scheduled Tribes may be given first priority in the absorption process.
- b. The exercise may be completed in 15 days.
