

**NATIONAL COMMISSION FOR SCHEDULED TRIBES**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Shri Banavathu Gopiya, S/o Chinna Bhikshalu, aged 50 years, resident of Hathiya Thanda, Nuzvid Mandal, Eluru District regarding no action being taken by the police in case of cheating.

Shri Banavathu Gopiya, S/o Chinna Bhikshalu, aged 50 years, resident of Hathiya Thanda, Nuzvid Mandal, Eluru District, belonging to Sugali (ST) community, vide his petition dated 16.12.2024, has stated that he established a water and soda manufacturing unit under the name M/s GB Bottlers after entering into an agreement with Saleel S. Nair and Rama Krishna of 1010 Foods and Beverages LLP, Chennai, and Tejavath Venkateswara Rao, for supply and marketing of machinery and products. He alleged that the accused persons, with criminal conspiracy, supplied substandard assembled machinery worth less than Rs. 1.25 crore while collecting Rs. 2.25 crore, causing him financial losses, and further failed to market his products, leading to his account with Bank of Baroda, Nuzvid Branch becoming NPA and auction proceedings being initiated. Though an FIR in Crime No. 384/2024 under Section 318(4) BNS was registered at Nuzvid Rural Police Station, no investigation or charge sheet has been filed even after six months. His grievance petition dated 05.02.2025 registered as ELR20250205479 under the AP Public Grievance Redressal System also yielded no action. He has requested the Commission to direct the Superintendent of Police, Eluru District to conduct a speedy investigation and file a charge sheet against the accused persons.

2. The Commission issued notice to the Superintendent of Police, District- Eluru vide NCST letter dated 08.09.2025 seeking facts and comments within 10 days.
3. No reply has been received hence the Commission decided to discuss the issue with the authority and the petitioner on 26.09.2025. Accordingly, a Sitting Notice was sent on 15.09.2025.
4. The petitioner has attended the hearing. The SDPO, Nuzvid has attended on behalf of the authority, SP Eluru.
5. The petitioner has informed that he was cheated and received the assembled machinery in place of genuine machinery which often went on for repair and no spare parts were made. Further as per the agreement they did not market the mineral water and soda produced leading to the financial bankruptcy.
6. The authority has informed that the investigation is in progress and letters were addressed to the Branch manager, Bank of Baroda, Nuzvid and Deputy Chief inspector of factories, Vijayawada for documents and the same are yet to be received and as the case is related to the receipt of documents from other departments and verification of the same, it might take some more time for investigation to prove prima facie against the accused.
7. After hearing to the petitioner and authority, the following recommendations are made and the ATR may be submitted in 15 days from the receipt of the Minutes.
  - a. The pending investigation may be expedited and charge sheet may be filed on the accused to pay the outstanding amount to the petitioner as per the agreement.
  - b. Meanwhile the Bank of Baroda may stop the auction proceedings temporarily for 2 months or till the settlement is made.
  - c. The Branch Manager, Bank of Baroda and Deputy Chief inspector of factories may attend to the next scheduled date of hearing.
  - d. The concerned authorities may enquire into the dealings of UV Tech and QOQO Company involved in such malpractices and halt all the transactions if proved.
