

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Anju (PF No. 347156, ex Peon, PNB, New Delhi) regarding reinstatement in service.

Smt. Anju (PF No. 347156, Ex Peon, PNB, New Delhi submitted a representation dated nil has alleged that she was unable to attend office for a few days as her husband was unwell, and she had a minor child to care. Therefore, could not inform the bank about absence. She has further stated that the Punjab National Bank, New Delhi, terminated her services without providing her a fair opportunity to explain.

2. In this matter, a sitting was held on 9.12.2024. In the sitting, it was recommended that "the case of the petitioner may be considered on humanitarian grounds, as informed by the GM in the sitting". The minutes were circulated on 27.1.2025 to all concerned.

3. The petitioner vide letter dated 06.05.2025 informed that no further progress had been made in her case. Thereafter, the case was discussed in the Review Meeting held on 7.8.2025 at PNB HQ, New Delhi under the chairmanship of Shri Jatothu Hussain, Hon'ble Member, NCST. In the Review Meeting the petitioner was advised to meet the officers of PNB regarding her case. However there is no progress.

4. Hence, the Commission has decided to discuss the issue with the concerned authority and petitioner on 16.10.2025. Accordingly, a sitting notice was issued on 06.10.2025. Meanwhile, the petitioner has informed that she met the concerned officers of PNB regarding her issue. The officers also assured that her case will be resolved within a month.





5. In the sitting, the Chief General Manager along with other Sr. officers of PNB and petitioner were present. The petitioner has again informed that the officers of PNB has assured that her issue will be resolved within a month. During the hearing, the officers of PNB have again re-assured that the issue of the petitioner will be resolved within a month.

6. After discussion with the above officers of PNB and petitioner, it was recommended that the management of PNB may resolve the case of the petitioner on humanitarian grounds. The petitioner is also advised to keep in contact with the management of PNB regarding her case.
