Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Dr. T. Tritva Jyothi Kiran, Asst. Professor, MCA Dept., AKNU MSN PG Centre, Kakinada, Andhra Pradesh regarding demand for immediate suspension and criminal action against students and staff for sexual harassment, criminal intimidation, and attempted murder of an ST woman faculty member under IPC and SC/ST (PoA) Act.

Dr. T. Tritva Jyothi Kiran, Assistant Professor (Ad-hoc), MCA Department, AKNU MSN PG Centre, Kakinada vide representation dated 3.12.2025 has alleged about the continuous sexual harassment, stalking, criminal intimidation, mob-style bullying and attempted murder by multiple batches of students and certain staff members over the past several years. She has stated that the harassment includes obscene gestures, sexually coloured remarks, vehicle intimidation, aggressive conduct during ICC proceedings, and threats to her life, job, home and livelihood, and that daily reports have been made at Thimmapuram Police Station. Invoking provisions of the IPC, UGC Regulations, 2015 and the SC/ST (Prevention of Atrocities) Act, 1989, she has sought immediate suspension of the accused students and staff, criminal action, protection of her employment and safety, and high financial compensation for mental trauma, emotional distress and professional damage, along with urgent intervention and directions from the Commission.

2. NCST vide notice dated 19.12.2025 sought facts and comments from the District Collector & Magistrate, District- Kakinada and Superintendent of Police, District- Kakinada and also Registrar, AKNU, Rajamahendravaram and the Principal, AKNU, Kakinada. The AKNU vide letter no. AKNU/Estt./SII/F.No. 52A/2026/1 dated 24.1.2026 has furnished the facts and comments. In the letter, it has been informed that the Department has constituted two committees to examine the issue. On the recommendations of the committees the department has terminated the services of the petitioner for the well being of the students and their academic future.

3. The reply was not satisfactory hence, NCST decided to discuss the issue on 17.2.2026 with the above authorities, Accordingly a Sitting Notice was sent on 06.02.2026 to all concerned and endorsement to petitioner.



4. In the sitting, the Registrar, AKNU and Principal, AKNU, Kakinada were present. The District Employment Officer, Kakinada was present on behalf of District Collector, Kakinada and there was no response from SP, Kakinada. The petitioner joined through Video Conference. The petitioner has reiterated her submissions and requested for justice. The officers of AKNU has reiterated their facts submitted to NCST vide letter dated 24.1.2026 and stated that the university has considered has transfer requests on medical/humanitarian grounds however the behavior of the petitioner with the students and faculty is always suspicious and rude. The petitioner was unable to produce any evidences/ facts regarding her grievance.

5. After discussion with the above officers and petitioner, it was observed that the action taken by the administration of AKNU appears to be appropriate, however considering her vulnerable status the University may take necessary action to unite her with her parents and also extend necessary possible help for overcoming her social insecurity by way of psychological counselling. At present no action warranted on part of NCST.
