

## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Shri Jadhav Sumesh, S/o Baliram, H.No.3-86, Nasnapoor, Utnoor, Adilabad, Telangana regarding gross irregularities in the appointment of Teachers with fake Caste Certificates in Agency Areas in the Teacher Recruitment Test (TRT).

Shri Jadhav Sumesh, vide representation dated 06/09/2025 has alleged that in TRT held in 2018, 57 candidates secured appointments by using agency area fake Local Scheduled Tribe certificates despite the District Collector's proceedings and District Level Scrutiny Committee (DLSC) enquiry identifying irregularities. However, no action has been taken despite appeals to Government officials, RTI applications, petitions seeking CBI enquiry and a CPGRAMS grievance (Docket No. MINHA/E/2025/0008297). Hence, requested for the justice.

2. NCST issued notice to the Commissioner and Director of Tribal Welfare Tribal Welfare Department, Govt. of Telangana on 14.11.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the Collector & Magistrate, Adilabad and Project Officer, ITDA, Utnoor and the petitioner on 18.02.2026. Accordingly, a Sitting Notice was sent on 06.02.2026.

3. In the sitting, the ACMO was present on behalf of PO, ITDA, Utnoor. There was no response from District Collector & Magistrate, Adilabad. The petitioner was also present. The petitioner has reiterated his earlier submission and alleged that the candidates appointed in TRT are having fake local ST Certificates, which needs to be verified for justice to the genuine ST candidates who have applied for the job. The officer of ITDA, Utnoor has provided a letter bearing no. D5/309/2018 dated 16.2.2026 of PO, ITDA, Utnoor. In the letter, it has been informed that the District Collector, Adilabad has cancelled the Agency Area certificate of the alleged candidates. Thereafter, the candidates have appealed the Secretary, Tribal Welfare Department, Govt. of Telangana for genuineness of Agency Area certificates. The department has set aside the order of District Collector, Adilabad. Accordingly, the appointments have been given.

4. After discussion with the above officer and petitioner, the following recommendations were made and action taken / to be taken report may be submitted to NCST within 07 days from receipt of the minutes. After receipt of the information, the further course of action will be decided by NCST.

a. The Secretary, TWD, Govt. of Telangana is advised to submit a detailed report on the circumstances that led to set aside the District Collectors proceedings and evidences if any to confirm the genuineness of the alleged candidates whose certificates were cancelled by the District Collector.
