Kokilaben Sumanbhai Patel, Prop: Kedaria Traders, S/4 Iconic Building, Taluka Panchayat Kacheri Road, Valsad, Gujarat-396001 regarding financial loss to scheduled tribe because of termination of contract on flimsy ground by M/s. Amazon Transportation Services Pvt. Ltd., Registered Office at Delhi.

Representation was received from Smt. Kokilaben Sumanbhai Patel, Prop: Kedaria Traders, S/4 Iconic Building, Taluka Panchayat Kacheri Road, Valsad, Gujarat-396001 regarding financial loss to scheduled tribe because of termination of contract on flimsy ground by M/s Amazon Transportation Services Pvt. Ltd., Registered Office at Delhi.


Shri H. C. Vasava, Hon'ble Member, NCST discussed this issue with the representative of M/s. Amazon Transportation Service Pvt. Ltd. and the petitioner in the sitting(s) held on 06/07/2017 and 08/05/2018. In the sitting held on 08/05/2018, after detailed discussion, Hon'ble Member, NCST suggested that the following information should be provided by M/s Amazon Transportation Services Pvt. Ltd. to the NCST within a month from the date of receipt of the proceedings, after that Commission will decide further course of action in the matter.

- (i) The point wise reply on the issue raised in the representation dated 11/04/2017 of Kedaria Traders should be submitted by the M/s Amazon Transportation Services Pvt. Ltd. to the Commission.
- (ii) Complete address (Name, Designation and Phone / Fax / Email) of the competent authority in M/s Amazon Transportation Services Pvt. Ltd. who competent to take decision should be informed.

The minutes of sitting was forwarded to M/s Amazon Transportation Services Pvt. Ltd., Nehru Place, New Delhi vide NCST letter dated 15/05/2018. Accordingly, Hon'ble Member fixed the sitting on 27/08/2018 to discuss the matter with the M/s Amazon Transportation Services Pvt. Ltd. and petitioner.

The petitioner again reiterated his grievances and requested for justice. The Senior Corporate Counsel, M/s Amazon Transportation Services Pvt. Ltd. informed to the Commission that the Company has changed the module. Therefore, it is not possible to accommodate the petitioner in the business. As per Master Service Agreement, the contract was terminated by the Amazon. It was also requested that the case may be closed, since the matter between M/s Amazon Transportation Services Pvt. Ltd. and petitioner being entirely commercial.

After hearing the both the parties, the Hon'ble Member decided that the case may be placed before the Hon'ble Chairperson, NCST. After that, if Commission feels, the matter would be taken up with the appropriate authority of the Govt. of Gujarat.
