Minutes of sitting held in the NCST's Headquarters on 28/08/2018 at 1:00 P.M. onwards under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Ms. Sadhna Dilip Patel, Aml, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Aml, Silvassa.



Ms. Sadhna Dilip Patel, Aml, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Aml, Silvassa. The NCST vide letter dated 23/05/2018 referred the representation to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of scheduled tribes of Dadra & Nagar Haveli.

Shri H. C. Vasava, Hon'ble Member discussed the issue with the Mamlatdar, Silvasa in a sitting held on 24/05/2018 wherein petitioner was present. In that sitting, Commission suggested / recommended that the District Administration (Revenue Department), Dadra & Nagar Haveli should submit the report on the following points to the Commission within one month from the receipt of the minutes.

- (i) Revenue Department (Mamlatdar, Silvassa) submit the facts before the concerned authorities that Smt. Sadhna Dilip Patel is the only owner of the said land.
- (ii) Employee(s) of the Revenue Department involved in this case be punished.
- (iii) The protection to Smt. Sadhna Dilip Patel and her family be provided by the District Police. If they face any kind of harassment / threaten from Shri Yogesh Patel, the District Administration will be responsible.

The reply was not received from the Administration of Dadra & Nagar Haveli. The Hon'ble Member fixed the sitting on 28/08/2018 to discuss the issue with the Administrator, D&NH, Collector, District Dadra & Nagar Haveli and Superintendent of Police, Dadra & Nagar Haveli. The Collector, Dadra & Nagar Haveli deputed Mamlatdar Silvasa to attend the sitting and no communication was received from the Police Department. The Hon'ble Member asked the petitioner to explain her grievance. She stated that the Administration is not taking appropriate action and Police Department is also not assisting in a proper way. She had also stated that the Municipality is also harassing her by laying the gutter line through her land. The Hon'ble Member asked the Mamlatdar to explain the action taken / proposed to be taken

by the District Administration in the matter. Mamlatdar informed that the matter has already been initiated and is under process with the Principal District and Session Judge, UT of Dadra & Nagar Haveli. The petitioner informed that the hearing is fixed for 07/09/2018.

After discussions, the Hon'ble Member suggested / recommended that (1) District Administration (Revenue Department) should place the facts that the petitioner is the real owner of the land before the Principal District and Session Judge, UT of Dadra & Nagar Haveli and concerned authorities (2) The District Administration should also call the facts from the Municipality on the laying of gutter line in the land of petitioner.

Action Taken Report in the case should be communicated to the NCST within 15 days. There after the next date of sitting will be decided by the NCST in the matter.
