Minutes of sitting held in NCST's Headquarters on 28/08/2018 at 1:00 P.M. onwards under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Luxibhai Govind Lotda, R/o Village – Amlu, Dokmardi, Silvassa (Dadra & Nagar Haveli) regarding grabbing of land of Scheduled Tribes.

List of participants is annexed.

Shri H. C. Vasava, Hon'ble Member, NCST discussed the issue with the Mamlatdar, Silvassa in a sitting held on 24/05/2018 wherein petitioner was also present. In that sitting, Commission suggested / recommended that:

- (i) The Revenue Department, (Mamlatdar Silvassa), Dadra & Nagar Haveli should submit the facts and comments on the issues, as raised in the representation dated 08/11/2017 within a month.
- (ii) Protection to the petitioner and his family be provided by the District Police. If they face any kind of harassment / threaten from Shri Suman Thakur Patel, the District Administration will be responsible.

The action taken report was not received from the Administration of Dadra & Nagar Haveli. The Hon'ble Member fixed the sitting on 28/08/2018 to discuss the issue with the Administrator, D&NH, Collector, District Dadra & Nagar Haveli and Superintendent of Police, Dadra & Nagar Haveli. The Collector, Dadra & Nagar Haveli deputed Mamlatdar Silvassa to attend the sitting and no communication was received from the Police Department. The Hon'ble Member asked the petitioner to explain his grievance. Petitioner stated that the case is pending before the Higher authority and the Revenue Department has distributed the compensation of the said land without waiting the outcome of the case which is against natural justice. The name of other legal highers entered by the Revenue Department are incorrect. This may please be verified and provide the justice.


The Mamlatdar explained that the compensation of the said land has been provided to the petitioner (including three others owners in equal parts). The Administration has followed due procedure.
