Representation dated 25.09.2017 received in the Commission on 29.09.2017, from Shri Ghasia Khalko, At-Qrs. No.-C/41, Sector-15, Rourkela-03, District- Sundargarh, Odisha-770032 regarding allotment of Quarter No. C/41, Cheap Type, Sector- 15, Rourkela on license basis to him as an ex-employee and land loser towards establishment of Rourkela Steel Plant. The same was forwarded to the District Collector, District-Sundergarh vide this Commission's letter of even no. dated 30.10.2017 to furnish the comments/information to this Commission at the earliest. Despite reminder dated 25.06.2018, no information was received in the Commission from the concerned authority.

2. Shri H.K. Damor, Hon'ble Member, NCST has decided to call a sitting on **27.08.2018 at 11.30 P.M.** in the Commission for discussion in the matter.

Gist of discussion/advice

Detailed discussion was held on the subject with the District Collector, District-Sundergarh, Orissa and the petitioner. The District Collector told that the CMD is the final authority of this matter, and he is not competent to decide the matter. Therefore, the Commission recommended to the CMD Rourkela Steel Plant, Rourkela, Orissa that as requested by Shri Ghasia Khalko, Quarter No. C/41, Sector-15, Rourkela-03, District-Sundargarh, Odisha-770032 should be allotted to him on license basis. It is also recommended that all dues pending from SAIL-RSP – Rourkela should be settled immediately. CMD, Rourkela Steel Plant is also requested to arrange to provide an action taken note within 30 days of receipt of this minutes.
