

Representation dated 14.08.2017 received from Shri Roshan Satardekar, General Secretary, Divyang Sena Happy Home, Thane Maharage Palika Shalejawal, Shanti Nagar, Wangle Estate Thane-400604, Maharashtra regarding verification of ST certificate of the employees of Ali Yavar Jung National Institute of Speed and Hearing Disabilities (AYJNISHED), Mumbai.

2. The matter was referred to the Secretary, Ministry of Social Justice and Empowerment, New Delhi vide this Commission's letter of even no. dated 07.11.2017 for furnishing the comments along with action taken report. Despite reminders dated 22.01.2018 and 14.03.2019, information was not received in the Commission from the Ministry.

3. Hon'ble Member, NCST has decided to call a sitting on **20.05.2019 at 11.30 A.M.** in the Commission to discuss the matter with the secretary, M/o Social Justice & Empowerment, Deptt. of Empowerment of Persons with Disabilities. The secretary, Deptt. of Empowerment of Persons with Disabilities deputed Under Secretary and the (Director, Ali Yavar Jung National Institute of Speed and Hearing Disabilities (AYJNISHED), Mumbai to attend the sitting. The petitioner was not appeared before the Commission in the sitting.






4. Hon'ble Member asked Director, Ali Yavar Jung National Institute of Speech and Hearing Disabilities (AYJNISHED), Mumbai that what action has been taken in the matter. The Director (AYJNISHED) stated that the matter was followed up with the issuing authority for verification of ST certificate. In response the same, the issuing authority informed that the records of certificates are not traceable. Further, the matter was taken with the District Collector and Magistrate, Alibag. In response to the same, no reply has been received from the District Collector till date.

5. After detailed discussion, Hon'ble Member (Hari Krishna Damor) advised to M/o Social Justice & Empowerment, Deptt. of Empowerment of Persons with Disabilities and the Director (Ali Yavar Jung National Institute of Speech and Hearing Disabilities (AYJNISHED), Mumbai, the matter may be taken up with the Chief Secretary, Government of Maharashtra, Mumbai. The action taken/to be taken in the matter may be intimated to the Commission within one month from the receipt of the processed of the sitting.
