Whereas the National Commission for Scheduled Tribes (NCST), as per the Constitutional mandate and as per powers conferred upon it under Article 338 A of the Constitution of India has decided to investigate into the aforementioned matter. An action taken report on the Commission's recommendations in the case is still awaited despite passing of stipulated periods.

5. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
