
Minutes of sitting held in NCST's Headquarters on 08/08/2019 at 11:30 A.M. under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Luxibhai Govind Lotda, R/o Village – Amlı, Dokmardi, Silvassa (Dadra & Nagar Havelı) regarding grabbing of land of Scheduled Tribes.

List of participants is annexed.

Shri Luxibhai Govind Lotda, R/o Village – Amlı, Dokmardi, Silvassa (Dadra & Nagar Havelı) regarding grabbing of land of Scheduled Tribes. The NCST vide letter dated 23/05/2018 referred the issue to the Administrator, U.T. of Dadra & Nagar Havelı, Silvassa for furnishing facts and comments. The NCST convened the sitting on the issue raised in the petition on 24.05.2018, 28.08.2018, 26.10.2018, 28.11.2018 and 22.01.2019 at Hqrs of NCST. The proceedings of sitting were sent on 20.02.2019 to all concerned for submitting action taken report on the recommendations to the Commission. The response was not received from the District Collector, Dadra & Nagar Havelı, Silvassa. A meeting was convened on 06.03.2019 at Silvassa with the Collector, D & NH, Silvassa and petitioner to resolve the issue by the NCST under the Chairmanship of Shri H.C. Vasava, Hon'ble Member, NCST.

In the meeting held on 06.03.2019 at Silvassa, the District Collector, Silvassa informed that the case will be examined by his office. The new date for hearing of the case will be fixed to resolve the issue. The minutes of meeting was issued to all concerned on 01.05.2019 with request to submit the action taken report to the Commission. The response was not received from the concerned authorities. Hence, the Hon'ble Member Shri H.C. Vasava fixed the sitting for 08.08.2019 at 11.30 AM to discuss the issue with the Administrator, UT of D & NH and District Collector, D & NH and the petitioner to assess the action taken by the Administration, D & NH.

In the sitting on 08.08.2019, the Resident Deputy Collector (s), Silvassa appeared from the UT of D& NH Administration. The petitioner was also present in the sitting. The Hon'ble Member asked the petitioner to explain the grievance and problems. The petitioner informed that the Administration has not taken any action to resolve the issue.



The Hon'ble Member asked the Resident Deputy Collector (s) to explain the facts and action taken by the Administration. The Resident Deputy Collector (s), Silvassa stated that the facts and information had already been submitted to the Commission vide letter No. RD/NCST/Laxi-Govan-Varli/2018/114 dated 07.08.2019. It was informed that the petitioner has filed an appeal against the Order dated 11.10.2017 of the Resident Deputy Collector (s) before the Court of Collector, D & NH. The next date of hearing scheduled for 07.08.2019.

After discussions with the Resident Deputy Collector (S), Silvassa and the petitioner, the Hon'ble Member recommended that the Collector, DNH should re-examine the case within a month from the date of sitting. The action taken/ to be taken in the matter may be submitted to the Commission at the earliest.
