NAND KUMAR SAI REGARDING REPRESENTATION OF SHRI BABU LAL MEENA AND OTHERS, NEW DELHI WITH REGARD TO PROMOTION TO THE POST OF CADRE OF ASSISTANT ACCOUNTS OFFICER OF IP & TAFS GROUP B CADRE FOR THE VACANCIES OF THE YEAR 2018-19



2. After welcoming the participants and their introduction, the petitioners were asked to explain their case.

3. The petitioners explained the case before the Commission and stated that they were denied promotion in the grade of Assistant Accounts Officer even after appearing in the Departmental examination in 2018 and obtaining the Bench mark of 30% as fixed by the Department for promotion for the said posts. They also apprised the Commission that there are many vacancies lying for the said posts and the backlog meant for ST category has so far not been filled up. They appealed to the Commission to direct the Department to promote them as Assistant Accounts Officer as they have already cleared the Bench mark as fixed by the Department.

4. The Sr. Deputy Director General (PAF), Department of Posts stated before the Commission that the petitioners, although they have obtained more than the total marks as fixed by the Department for making them eligible for promotion of the Assistant Accounts Officer, they could not obtain the passing marks fixed for each paper. The Department is also very much concerned about filling up of vacant posts in the SC/ST categories which could not be filled up for this reason. He further stated that the Department is approaching the Department of Personnel & Training for obtaining their comments for further relaxation of the passing marks in individual papers so that the vacant posts could be filled up in the category of Scheduled Castes and Scheduled Tribes and thereby benefit the petitioners also.

5. Since, the qualifying marks and other criteria are set by the Department, the Commission finds no valid reason for the Department of Posts to seek the advice of DoPT. Therefore, the Commission took very serious note of the petitioner's grievance and recommends to the Department to resolve the matter by giving further relaxations/grace marks in individual papers to the ST candidates and fill all the ST vacancy by 31st December, 2019 positively and send an action taken report to the Commission in the matter.
