

Shri Danjibhai Dhavajibhai Bhoja, Bermal- Pada Of Mota Randha, (D&NH) Silvassa vide representation dated 12.2.2019 has stated that regarding Non - Cooperation by the Revenue Department of Silvassa and requested for justice. The NCST vide letter dated 15.9.2019 has referred the representation District Collector, Silvassa for facts and comments. The response was not received. The Hon'ble Member decided to discuss the matter on 10.12.2019 with the District Collector, Silvassa and petitioner to resolve the issue. The sitting notice was issued on 27.11.2019.

The Resident Dy. Collector (S), D&NH Silvassa vide letter No. RD/RTS-II/Varsai-Case/05/2015/5391 dated 09.12.2019 had intimated that due to important and urgent issue of merger of UTs of Daman & Diu and Dadra & Nagar Haveli, the administrative is engaged in the preparation for the said merger. Thus, exemption may kindly be granted from appearing personally in the sitting. A copy of the brief of the case was enclosed with the letter. The petitioner was present in the sitting on 10.12.2019 at 12:00 Noon.

The Hon'ble Member asked the petitioner to explain the problem and comments on the information furnish<sup>d</sup> by the Revenue Department of District, Silvassa. The petitioner informed that the information mentioned in para-2 of the report of the case submitted by Revenue Department, Silvassa with their letter dated 09.12.2019 is not correct. The relevant documents have not been provided by the Revenue Department so far, after depositing the requisite fee.

The Hon'ble Member took this matter seriously and recommends that Revenue Department of District Silvassa should provide the requisite documents to petitioner as mentioned in his representation dated 12.2.2019 within 15 days from receipt of proceedings. A copy of the same also be provided to NCST for further action.
