Minutes of meeting held in the Chittaranjan Locomotive Works (CLW) on 07/2/2020 under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST on the issues related with the Chittaranjan Locomotive Works, District West-Burdwan (West Bengal).

List of participants is annexed.


2. The Zonal Secretary, All India SCs and STs Railways Employees Association, CLW had requested for restoration of former logo of CLW (Bow & Arrow i.e. Teer & Kaman) vide representation dated 01.12.2018. Accordingly, the matter was referred to Chairman, Railway Board on 13.02.2019 for furnishing the facts and comments. The following issues were brought to the notice of Hon'ble Chairperson, NCST when the Commission was on visit of West Bengal & CLW (i.e. on 25.02.2019).

- (a) Restoration of former logo of CLW (Bow & Arrow i.e. Teer & Kaman).
- (b) Non permission for installation of statue of Shri Jaipal Singh and Dr. B.R. Amedkar in the office of All India SCs & STs Railway Employees Association, CLW.
- (c) Threatening to office bearers of All India SCs & STs Railway Employees Association, CLW by the Management.
- (d) Acquisition of land for setting up of Chittaranjan Locomotive Works and implementation of RR policy for the affected STs persons.

3. In this context, a sitting was convened by NCST on 26.9.2019 at New Delhi under the Chairmanship of Hon'ble Chairperson, NCST with the General Manager, CLW and representative of Railway Board and petitioners. The minutes of sitting was sent on 18.10.2019 to Railway Board and CLW for submission of action taken report on the recommendations of the Commission.

4. The CLW vide letter No. GMA/Resv/NC/2019/Pt.II dated 05.12.2019 has furnished the action taken report on the recommendations of the Commission. In respect of recommendation/suggestion for "Restoration of former logo of CLW (Bow & Arrow i.e. Teer & Kaman), the CLW informed that a proposal for restoration of old official logo (Bow & Arrow) in CLW has been sent to Railway Board vide letter No. GMA/Res/NC/2016 dated 03.10.2019, as the said logo was discontinued vide Railways Board letter No. 2007/PR/13/5 dated 12.3.2007.

In respect of permission of installation of statue of Shri Jaipal Singh Munda & Dr. B.R. Ambedkar in the office of the All India SCs & STs Railway Employees Association, the CLW informed that no further action is pending at the Administration CLW.

5. Meanwhile, Zonal President and Secretary, All India SCs & STs Railway Employees Association, CLW vide letter No. AISCTREA/CLW/NCST dated 13.12.2019 had requested the Hon'ble Chairperson for consent as Chief Guest to inaugurate (i) the statue of Babasaheb Dr. B.R. Ambedkar, (ii) portrait of Shri Jaipal Singh Munda and (iii) Library at office premises of Association.

6. The Hon'ble Chairperson, NCST acceded the request of association and decided to convene a meeting on 07.2.2020 with the CLW Administration to discuss the implementation of recommendations of Commission and inaugurate the statue of Dr. B.R. Ambedkar at CLW.

7. The Hon'ble Chairperson, NCST inaugurated the statue of Babasaheb Dr. B.R. Ambedkar and unveiled the portrait of Shri Jaipal Singh Munda & Library at office premises of association on 07.2.2020 at CLW, Chittaranjan.

8. Prior to meeting with the CLW Management, the Commission met the office bearers of Zonal Office of All India SCs & STs Railway Employees Association (AISCTREA), CLW. The office bearers of AISCTREA, CLW had submitted the following demands for justice:-

1. Non-payment of long pending settlement dues to the family members of late Raghu Hnsda Ex. T/No-21/775 (of the year 2004)
2. Filling up ST & SC back log vacancies.
3. Filling up the 40% induction quota against notification No. MW/MR/21 Pt.X (panel) dated 12.4.2018 and provision of age relaxation for ST employees.
4. Non-payment of settlement dues, family pension and CGA except PF to the family of (a) late Banewar Marandi, Ex. Sanitary cleaner under Dy. CPO (W) (b) Late Mahadev Marandi Ex T/No-19/1040 expired on 06.7.2015, (c) Late Lakhan Mohali.
5. Compassionate Ground appointment of Shri Sonaram Hansda (ST), S/o late Lakhai Hansda, Ex. S/Cleaner has been regretted by CLW Admn. Vide No. GMA/RS/81 Pt.XI dated 14.9.2019. In addition maximum CGA cases belong to SC/ST.
6. Timely grant of Family Pension to the Widow Daughters, Unmarried daughter and divorce daughter of the Ex. Employees belonging to ST community.
7. To evolve promotional avenue for serving Sanitary Cleaner under Health & Maleria Inspector of Dy. CPO/W office, Engg. Deptt. and Medical Department.
8. Compassionate Ground Appointment after completion of medical test of ST candidate, immediately.
9. Children park in Chittaranjan Township to be renamed as Shri Jaipal Singh Munda Park.
10. To save the Principal Chief Material Manager (PCMM) Kolkata Office.
11. Inclusion of ST & SC member in each area committee as there is no reservation for ST & SC.
12. Transfer cases on spouse ground vide RBs of khokan karmakar from Mumbai Inspection Cell to CLW/CRJ.
13. TKO staff are being deprived from getting split duty allowance same as to other clerical staff working inside workshop.


14. ST-01 and SC-04 Junior Engineer/Mech have been reverted recently who were promoted under best among the fail candidate vide office order no-MW/S/E/I/M release, dated 03.12.2019

15. Implementation of incentive Policy at ELAAU/Dankuni.

9. The Hon'ble Chairperson, NCST in his opening remarks mentioned about the responsibility of the NCST and, thereafter, asked CLW officers to give clarification on the above issues raised by AISCTREA and implementation of recommendations of sitting held on 26.9.2019 at HQrs of NCST at New Delhi.

10. The officers of CLW informed that, the CLW has already referred the matter to Railway Board for restoration of former logo of CLW (Bow & Arrow). The opinion/views of Railway Board is awaited. In respect of entrusting works of fishing and cultivation to the effected ST families on the ponds and land under the control of Management of CLW, it was informed that this issue have been covered under the instructions of Railway Board issued vide letter No. 2009/LML/16/3 dated 16.7.2010.

11. After detailed discussion with the officers of CLW, the Commission recommends that the Management of CLW should consider the above demands of AISCTREA, CLW and re-examined the issue on sympathetic ground for entrusting the works of fishing and cultivation to the affected ST families in view of the "Right to Use" policy. The matter for restoration of former logo of CLW (Bow & Arrow) be taken up with the Railway Board on priority basis. The meeting with the AISCTREA, CLW be convened regularly. The hockey stadium be re-named in the name of Shri Jaipal Singh Munda. The action taken report on the recommendations may be submitted to the Commission within 30 days positively.
