

Subject: Proceedings of the Sitting held under the Chairmanship of Hon'ble Vice Chairperson, NCST, to discuss the case of Shri Nabor Ekka, President, Indian Confederation of Indigenous and Tribal People, C/o C, W.W.S., Plot No. 1, West Kidwai Nagar, New Delhi regarding non filling the vacant posts of Staff Nurse under post code 20/13 under scheduled tribe category in Govt. of NCT of Delhi.

1. The Sitting was held in the Conference Room of NCST on 29/08/2016 at 5:00 P.M. under the Chairmanship of Hon'ble Vice Chairperson, NCST to discuss the matter, as cited above.
2. List of participants in the Sitting is as at Annexure A.
3. Secretary, (HMFWD), Health & Family Welfare Department, Govt. of NCT of Delhi vide letter No. DH&FW-S012/117/2016-Internal Admin-Secy (H&FW)/573 dated 29/08/2016 has requested for exemption of his presence and also nominated, Ms. Manju Handa, Deputy Secretary, (Health) to attend the hearing. Hon'ble Vice Chairperson has allowed the same.
4. During discussion the Hon'ble Vice Chairperson has asked the petitioner to present the case, before the Commission.
5. Petitioner has explained that Delhi Govt. has notified vacancies of staff nurses vide their advertisement dated 15/03/2013 regarding availability of 244 vacancies of staff nurses and only 241 candidates have been selected and 18 posts have remained vacant. Candidature of 18 candidates have been cancelled and the vacant posts of staff nurse have been filled on contractual basis.
6. Ms. Manju Handa, Deputy Secretary has explained the facts and has stated that advice of NCST will be considered on priority.
7. The Hon'ble Vice Chairperson advised that Delhi Govt. may appoint the 18 Scheduled Tribes candidates who have qualified for appointment for the post of staff nurse, as filling up the vacant posts on contract is not justified, when there are candidates available for regular appointment. Hon'ble Vice Chairperson also directed to submit a compliance report within 15 days.

The Sitting ended with the vote of thanks to the chair.
