Therefore, Shri Harshadbhai Chunnilal Vasava, Hon'ble Member, NCST has desired to discuss the matter **in person** with you and accordingly fixed a sitting on **08/06/2017 at 11:30 A. M.** in the Commission at Conference Room, 6<sup>th</sup> floor, Loknaya Bhawan, Khan Market, New Delhi for investigation / inquiry / action taken in the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India.
