Sub: Minutes of the Sitting, under the Chairmanship of Hon'ble Member(HKD), in the case of Shri Ravindra Meena, Junior Engineer(C)/DDA held on 22.08.2017 at 2.30 P.M. in the National Commission for Scheduled Tribes.

1. This is regarding the Sitting under the Chairmanship of Hon'ble Member (HKD), National Commission for Scheduled Tribes, to discuss the case of Shri Ravindra Meena, held in the Conference Room, National Commission for Scheduled Tribes at 2.30 P.M. on 22.08.2017.
2. The list of participants is given at Annexure 'A'.
3. Initiating the discussion the Hon'ble Member, NCST (HKD) asked to the petitioner to submit his grievances. Shri Ravindra Meena explained that although the Department has given promotion to the post of Assistant Engineer(C) on In-situ basis which has resulted not getting any tangible advantage of counting of service for future promotion etc. He has further stated that backlog vacancies under ST Quota is 29 posts which are lying vacant in the Department and only three incumbents in the pipe line out of which two are seniors to him.
4. The Hon'ble Members, NCST asked the Director (Personnel), DDA to explain the reason why the DDA has not given the regular promotion to Shri Meena. Director (P) explained that the cadre review of Engineering Cadre of DDA was approved by the Govt. of India in 2012. The Case of Shri Meena was assessed fit by the DPC for promotion to the post of AE(C) for the year 2016-17 on In-situ basis.
5. The Hon'ble Member, NCST (HKD) has stated that when the vacancy under ST quota is available why DDA has not given regular promotion to Shri Ravindra Meena so far.
6. The Commission has taken a serious note of the fact that there are backlog vacancies available for the Scheduled Tribe employees, but still they are not given regular promotion but only in-situ' promotion.
7. The Commission, therefore, advised DDA to examine the case on priority and effect regular promotion to ST employees as backlog posts are available. This exercise is to be completed within two months from the date of the Sitting of the Commission is 22.08.2017.
8. The Sitting ended with vote of thanks to the Chair.
