Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 23.07.2024 in the case of Shri Rakshit, Town- Ranebennur, PS- Ranebennur, District- Haveri, Karnataka.

A representation dated 15.05.2022 was received in the Commission from Shri Rakshit, Town- Ranebennur, PS- Ranebennur, District- Haveri, Karnataka regarding the complaint on behalf of his Uncle, Aunt and their family who has been subject to physical violence and harassment by caste abuse. No action has been taken by the Police instead petitioner's uncle has been arrested and no bail is being granted to him. The petitioner alleged that the complaint on behalf of his Aunt and her family who have been subjected to physical violence and verbal abuse by the neighbours due to a land dispute. A FIR No.002/2022 has been filed on 06.01.2022 at the Ranebennur Police Station. No action has been taken by the Police against the accused on the contrary the petitioner's uncle has been arrested and no bail is being granted to him. Petitioner requested the Commission to intervene in the matter.

2. The Commission issued Notice to the Superintendent of Police, Haveri, Karnataka on dated 02.08.2022 for ATR/Reply within 15 days.

3. In response to NCST notice dated 02.08.2022, No reply/ATR received from The Superintendent of Police, Haveri Karnataka. In this matter the Commission fixed a Sitting on 23.07.2024 with the Superintendent of Police, Haveri, Karnataka.

4. On behalf of the Superintendent of Police, Haveri, Karnataka, Deputy Superintendent of Police, Ranebennur, Karnataka was present in the Sitting. The petitioner Shri Rakshit was not present in the Sitting.


