Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 23.07.2024 in the case of Smt. Vinutha DN, W/o Shri Shashikanth, No.19, 8th Cross Agrahara Dasarhalli Bangalore, Karnataka.

A representation dated 11/02/2024 of Smt. Vinutha DN, W/o Shri Shashikanth, No.19, 8th Cross Agrahara Dasarhalli Bangalore, Karnataka was received in the Commission, wherein it was stated that she was abused with caste remarks by her Father-In-Law, Brother-In-Law and Sister-In-Law. She submitted that she got married with Shri Shashikanth who belongs to upper caste. Her father-in-law was against the wedding because she belongs to ST community. On 31.07.2023, they went to visit her mother-in-law, she called them over phone to stay with her for few days. They reached there, her father-in-law, co-sister and brother-in-law used derogatory caste words and manhandled her. She has given a complaint to the Commissioner of Police and the Commissioner of Police directed the Magadi Road Police for inquiry. But they called the petitioner to the Police station for compromise with all the 3 people and take back the complaint. She requested the Commission to interfere in the matter. The petitioner is seeking an appropriate action on her complaint.

2. Commission issued Notice to the Commissioner of Police, Bangalore, Karnataka on dated 30.04.2024 for ATR/Reply within 15 days.
3. As No reply/ATR received from the Commissioner of Police, Bangalore, Karnataka, the Commission fixed a Sitting on 23.07.2024 with the Commissioner of Police, Bangalore, Karnataka.
4. On behalf of the Commissioner of Police, Bangalore, Karnataka, The Asst. Commissioner of Police, Vijaynagar, Bangalore, Karnataka was present in the Sitting. The petitioner Smt. Vinutha DN was present in the Sitting on video call.
5. The matter was examined in detail. The Asst. Commissioner of Police, Vijaynagar, Bangalore, Karnataka presented details of the case before the Commission. He informed that there is a property dispute and civil suit is going on in the family, FIR is also been filed. Petitioner stated that Police authorities didn't register her complaint and kept her seated whole day in police station. Her father in law didn't give her entry in his house when she went to visit hometown.
6. After hearing the matter, the Commission recommends that:
 - ACP Ravi, SI Sumangda and Inspector Raju related with the incident, to be called in the next Hearing.
 - Fresh investigation in the matter to be done within 30 days.

Action taken report to be submitted in the commission within 30 days.
