

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, regarding harassment of Shri P. Ramakrishna, Lecturer by Govt. College of Men (Arts), Andhra Pradesh of Shri P.V. Ramana, National President, All India Scheduled Tribes Employees Association, Mallapur, Hyderabad.

Shri P.V. Ramana, National President, All India Scheduled Tribes Employees Association, Mallapur, Hyderabad vide his representation dated 30.05.2024 has alleged that higher officials of Govt. College of Men (Arts), Kadapa, Andhra Pradesh are verbally caste abusing, harassing and humiliating Shri P. Ramakrishna, Lecturer of Geology. It is further alleged that higher officials of the college is also biased and showing disparity towards Shri P. Ramakrishna.

2. NCST vide Notice dated 24.08.2024 had referred the matter to Secretary, Higher Education Department, Govt. of Andhra Pradesh, Guntur, Andhra Pradesh for comments within 15 days. No reply was received from concerned authority.
3. NCST has decided to discuss the issue with the authorities and the petitioner on 16.10.2024 and Sitting Notice was sent to concerned authority and petitioner vide NCST letter dated 03.10.2024. Secretary for Higher Education Department, Govt. of Andhra Pradesh vide letter dated 11.10.2024 deputed Commissioner of Collegiate Education, Govt. of Andhra Pradesh to attend the Sitting. Commissioner of Collegiate Education, Govt. of Andhra Pradesh vide letter dated 14.10.2024 deputed Joint Director, O/o the Commissioner of Collegiate Education, Andhra Pradesh to attend the Sitting. Joint Director, O/o the Commissioner of Collegiate Education, Andhra Pradesh appeared in the Sitting while the petitioner was not present. The officer provided the copy of letter dated 10.10.2024 from Principal, Governemtn College of Men (A), Kadapa, Andhra Pradesh addressed to Commissionerate of Collegiate Education, Magalgi, Andhra Pradesh wherein it has been mentioned that petitioner has withdrawn his complaint alongwith copy of letter dated 10.10.2024 duly signed by petitioner addressed to NCST.
4. After receiving information from the concerned authorities, it was observed that no further action was requisite on the part of NCST and the case may be closed.
