Minutes of the Sitting chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 15.10.2024 in the case of Smt. K.P. Vijayalakshmi W/o Shri R. Munaswamy, Flat No. 182, G.O.S. Colony, Peruru Village, District- Tirupati Andhra Pradesh regarding extra marital affair.

1. A representation dated 20.02.2024 was received in the Commission from Shri Kothapalliajeya Kumar, AP State Co-Convener, BJP Legal Cell, Andhra Pradesh along with a copy of representation dated 20.02.2024 of Smt. Vijayalakshmi, Tirupati District, AP regarding harassment against her daughter R. Jyothirmai. In the representation she alleged that her daughter R. Jyothirmai was married to Shri P. Raghuvaran on 23.05.2021. Unfortunately, a woman named Smt. V. Nagalakshmi trapped Shri P. Raghuvaran and is causing disturbances to her family. She requested the Commission to intervene in the matter.
2. The Commission issued Notice to the Collector & District Magistrate, District- Annamayya, and Superintendent of Police, District - Annamayya, Andhra Pradesh on dated 06.03.2024 for ATR/Reply within 15 days.
3. In response to Commission's notice dated 06.03.2024, a reply dated 17.04.2024 was received from the Superintendent of Police, District - Annamayya, Andhra Pradesh, wherein it is stated that the respondent Shri P. Raghuvaran was in relationship with the accused lady Smt. V. Nagalakshmi even before the marriage of her daughter with Shri P. Raghuvaran. He has also filed a divorce petition in the family court.
4. The District Collector, Annamaya and Superintendent of Police, District - Annamayya, Andhra Pradesh appeared in the Sitting through Video call. The petitioner Smt. K.P. Vijayalakshmi also appeared in the Sitting on video call.

5. The matter was discussed in detail. The Superintendent of Police, District - Annamayya, Andhra Pradesh submitted details of the case before the Commission.

6. After hearing the matter, the Commission recommends that:

- The counselling to be given to Shri P. Raghuvaran and Smt. K.P. Vijayalakshmi and to explore all the possibilities of uniting them.
- Women and Child Welfare Department may be involved in this process.
- The issue to be sorted out in a month's time.
