Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding the harassment of ST employee by denial of promotion and not releasing the salary by Administration of Kakatiya University, Warangal – a representation dated 04.03.2023 of Dr. Korra Cheena, Assistant Professor, University College of Engineering, Kakatiya University, Warangal regarding salary and promotion.

Dr. Korra Cheena, Assistant Professor, University College of Engineering, Kakatiya University, Warangal vide representation dated 04.03.2023 had alleged that the Administration of Kakatiya University, Warangal was harassing him by stopping his salary without giving any reason and not giving promotion.

2. In the matter a sitting was convened in the NCST on 26.06.2024. The following recommendations were made and the University administration was asked to furnish the ATR by 16th July, 2024.

- The process may be initiated to release the salary of the petitioner.
- The process for granting PhD increments to the petitioner may also be initiated.
- The process for promotion of the eligible employees (including petitioner) under CAS scheme to be initiated.
- The petitioner is advised to furnish the information regarding the Writ Petitions/Contempt Petitions, if filed by him, before Hon'ble High Court.


3. The ATR was not received from the University. Hence, the Commission decided to discuss the issue with the VC, Kakatiya University and petitioner on 06.11.2024 at 12:20 PM in NCST. Accordingly the sitting notice was issued on 28.10.2024.

4. The Registrar, Kakatiya University vide letter no. 671/A2/KU/2024 dated 5.11.2024 has furnished the facts and stated that the present VC assumed the charge on 19.10.2024. Hence, it is regretted to informed that he is unable to attend the personal appearance. The documents related to the case sent to the commission and requested to close the case.

The petitioner was present in the sitting and he informed that the University has released the and increments in his favour. The petitioner has provided a copy of the Orders of the Hon'ble Court of Telangana in the Writ Petition No. 5571 of 2024 (dated 18.10.2024) and Writ Appeal 270 of 2024, 279 and 305 of 2024 (dated 16.08.2024 of 2024) and requested for justice.

6. On the basis of orders the Hon'ble High Court of Telangana as cited above, it was recommended that the copy of above orders of Hon'ble High Court of Telangana may be forwarded to VC, Kakatiya University for taking up matter with the concerned Department of Telangana State for redressal of grievance of the petitioner. The Kakatiya University is advised the action taken/ to be taken in the matter and submit the Action Taken Report to NCST under intimation to petition within a month from receipt of the minutes.
