Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding atrocity and obstruction of an Ambulance leads to the death of ST patient in the case of Shri Ramadas Jadav, National President, Jusitice for People Rights Forum, Kalluru - P.O, Khammam - Distt. Telangana.

Date of the Sitting: 27/1/2025, 4:00 PM Participants in the Sitting: As per Annexure

Shri Ramadas Jadav, National President of the Justice for People Rights Forum, Kalluru P.O., Khammam District, Telangana vide representation dated 03.06.22 and alleged regarding an atrocity and the obstruction of an ambulance, which led to the death of an ST patient. He alleged that on 16.02.2022, an ST person suffering from a serious illness was being transported by ambulance from Bhadradri Kothagudem Hospital to Khammam District Hospital but did not survive and was declared dead due to the obstruction of the ambulance by a rally and the denial of passage for the vehicle. This incident is attributed to the negligence of the police. The petitioner claimed that if the ambulance had been provided smooth access, the patient's life could have been saved.

- 2. In this matter, sittings were held on 8.11.2022, 15.03.2023 and 19.2.2024. In the last sitting on19.02.2024, the following recommendations were made and minutes were forwarded to all concerned authorities on 27.02.2024 for furnishing the information within 30 days.
- The pending salary of the petitioner be paid immediately.
- Pension in serious cases be initiated as soon as possible.
- Monthly salary payments be ensured and be paid on time.
- Compensation under the Apathbandhu Scheme be provided to the victim.
- · Medical treatment for the victim be ensured on top priority.
 - 3. The Collector & District Magistrate, Bhadradri Kothagudem vide letter no. C2/4190/2022 dated 28.05.2024 has furnished the action taken report, which was forwarded to petitioner on 12.09.2024 for information. Thereafter, NCST has decided to discuss the issue on 27.1.2025 with the authority and petitioner. Accordingly, a sitting notice was issued on 14.1.2025.
 - 4. In the sitting the Collector & District Magistrate, District Bhadradri Kothagudem and petitioner were present. The Collector & District Magistrate, District Bhadradri Kothagudem has provided a copy of letter no. C2/4190/2022 dated 25.1.2025 containing the facts and comments related to the case. The petitioner has appraised his grievance in the sitting.

- 5. After discussion with the Collector & District Magistrate, District Bhadradri Kothagudem and petitioner, the following were recommended and action taken thereon may be furnished to NCST within 30 days from receipt of the minutes:-
- a. The agency may be directed to pay the remuneration to the outsourcing employees immediately.
- b. The Housing scheme may be sanctioned under Indiramma Illu.
- c. Bank loan may be sanctioned to the petitioner for setting up any livelihood unit or preferably Dairy unit.

After the submission of ATR, the case may be closed as a successful case.
