Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Dr Kalyan Nayak, BJP ST Morcha State President, Hyderabad, Telangana regarding permanent closure of Shyamala Ramavath Road Metal Company.

**Date of the Sitting: 10/02/2025, 03:20PM**  
**Participants in the Sitting: As per Annexure**

Dr. Kalyan Nayak, BJP ST Morcha State President vide his representation dated 12.08.2024 has stated that Shyamala Ramavath Road Metal Company, operating in Gazi Nagar Village, Mallepalli Mandal, Nalgonda District (Survey No. 342) is violating permissions and causing severe environmental and public health hazards. He alleges that the company is operating close to residential areas, agricultural fields, and an ancient Ram Temple identified by the Archaeology Department, leading to water pollution, health issues such as lung diseases and cancer and fatal accidents due to tipper movement. Further, he claims that the company is running without an NOC from the Pollution Control Board, evading taxes, and illegally occupying government land through record tampering. He urges that the company, which endangers ST lives, be shut down immediately.

2. The Commission issued notice to the District Magistrate, District- Nalgonda, Telangana vide NCST letter dated 04.10.2024 seeking facts and comments within 15 days.

3. The District Magistrate, District- Nalgonda vide reply dated 02.11.2024 informed that Venkateshwara Minerals' mining lease expired in 2009, and operations ceased in February 2023, with no reported environmental or religious concerns. Shyamala Ramavath Road Metal Company with a valid lease until 2030 was found operational and compliant with environmental norms, with no local complaints. Both companies had necessary approvals and no illegal mining was detected.

4. A sitting was scheduled on 07.11.2024 but the authority did not appear while the petitioner was present. NCST again decided to discuss the issue with the authority and the petitioner on 10.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.

5. The District Magistrate, District- Nalgonda vide letter dated 5.2.2025 has mentioned that due to election to Telangana Legislative Council, could not able to attend the sitting and deputed Addl. Collector, Nalgonda and Asst. Director (Mines & Geology), Nalgonda to attend the sitting.

6. In the sitting the above officials were present on behalf of District Magistrate, District- Nalgonda and the petitioner was also present. The petitioner reiterated its earlier submission. The officials of District Nalgonda reiterated its earlier facts submitted to NCST vide letter dated 2.11.2024.

7. The petitioner has informed that the said unit is just 400 meters from Thanda and the borewells and tanks are polluted by the dust and the houses in NTR nagar are damaged with cracks occurred due to shocks of blasting and fatal accidents have occurred due to tipper movement. It is further informed that the mining lease is expired in 2009 and has been renewed in 2020, causing a revenue loss to the Government.

8. The authority has informed that as the said unit is more than 1 kilometre distant from the tribal habitation and falls under the Orange Category the Pollution control board do not conduct the public hearings. It is further informed that the mining department is capturing the pictures and periodical reports as per the mandated regulations are being submitted to Mines safety and explosives Department. Further it is informed that letter of intent is given by the department.

9. After the discussion with the officers of District Administration, Nalgonda and petitioner, the following recommendations were made and the action taken report may be submitted within 30 days from the receipt of the minutes.

- a. Gram sabha/ Public hearing in all the affected thandas may be conducted with videography and the report may submitted to NCST.
- b. Pollution control Board may submit a report with environmental clearance and mining plan.
- c. The Department of mines may submit as to why the delay happened in renewal of the permission.
- d. The details of the total IT and tax, mineral fund etc collected during the period of absence of NOC ie, from 2009-2022 may be submitted to NCST.
- e. The details of the deaths that have occurred in the ST Habitations adjacent to the said mining area along with the reasons may be submitted to NCST.



