Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Dr Kalyan Nayak, BJP ST Morcha State President, Hyderabad, Telangana regarding implementation of 10% reservation for STs in Telangana's medical and health departments, outsourcing agencies, and hospital-related contracts.

Date of the Sitting: 10/02/2025, 04:00PM Participants in the Sitting: As per Annexure

Dr. Kalyan Nayak, BJP ST Morcha State President, vide his representation dated 26.08.2024, has stated that the Rule of Reservation for tribals, mandating 10% recruitment, is not being implemented in Telangana's medical and health departments, outsourcing agencies, and hospital-related contracts. He highlights that appointments are being made arbitrarily, bypassing reservation norms, thereby depriving tribal candidates of employment opportunities. He demands strict adherence to the 10% reservation rule in outsourcing contract agencies, recruitment agencies, job promotions, and government contracts across the state, including sanitation, diet departments, and hospital food courts, to ensure fair representation and opportunities for tribals.

- 2. NCST vide notice dated 13.11.2024 had referred the matter to Chief Secretary, Telangana for seeking facts and comments within 30 days. Since no reply was received hence NCST decided to discuss the issue with the authority and the petitioner on 10.02.2025. Accordingly, a Sitting Notice was sent on 31.01.2025.
- 3. The Resident Commissioner, Govt. of Telangana, Telangana Bhawan, New Delhi appeared on behalf of Chief Secretary, Govt. of Telangana in the sitting and has informed that the Secretary of concerned Department may take action and requested to exempt the Chief Secretary from the respondents and add the Secretary, Health, Medical and Family welfare Department as the respondent. The petitioner was also present.
- 4. After discussion with the officer of Govt. of Telangana and petitioner, the following recommendations were made and the action taken report may be submitted within 30 days from receipt of the minutes.
- a. The Secretary, Health Department, Government of Telangana may submit the details of Contract and outsourcing staff engaged in the Hospitals, Medical colleges and institutions relating to the Department and ensure that the 10% Reservation for STs is being followed. b. The Secretary, Health, Medical and Family welfare Department, Government of Telangana may attend the next scheduled date of hearing.
