The National Commission for Scheduled Tribes (NCST) is a constitutional body set up under Article 338A of the Constitution of India to investigate and monitor all matter relating to protection, welfare and socio-economic development of Scheduled Tribes in the country. As per constitutional provisions, the Union and every State Govt. shall consult the Commission on all major policy of decisions affecting Scheduled Tribes. The Commission is required to present to the Hon'ble President of India reports upon working of those safeguards and all such reports are to be laid before each House of Parliament along with Memorandum explaining the Action Taken or propose to be taken on the recommendations relating to the Union and the reasons for non-acceptance, if any, of any of such recommendations.

2. In pursuance of the above constitutional mandate, Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes accompanied by Shri Ashok Lakkarasu, PS to Hon'ble Member (JH) visited State Home of Boys at Saifabad and State Home for Girls at Nimboliadda, Kaheguda, Hyderabad to understand the nature of grievances of STs in Juvenile Welfare Department and redressal mechanism and to give certain recommendations for effective implementation of constitutional safeguards for the students and employees belonging to Scheduled Tribes.

3. Deputy Director Charvak, Superintendent Naveen Kumar, Welfare officers Sayyid Afzal Shah ali, Sangameshwar, Smt Maithili, Doctor Rajanna and JJB member Vasu participated in the meeting.

Juvenile Home for Boys-Saifabad

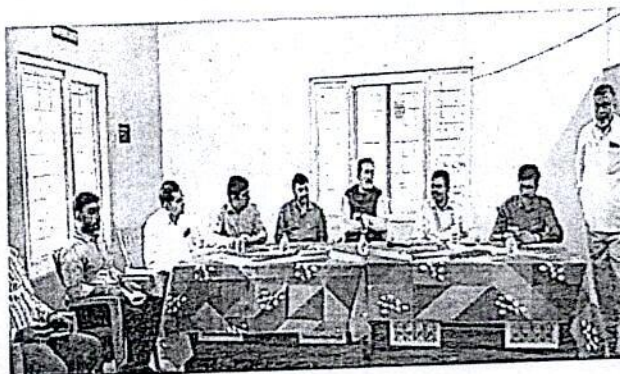
The Hon'ble Member has interacted with the children and advised them to cooperate with the teachers and focus on their studies during their stay in the Juvenile Home.

Interacted with the inmates of the Correctional home and suggested that they shall not be attracted for short term momentary satisfaction but focus on good deeds that could gain the reputation to them and their parents .

The Hon'ble member witnessed the Sports talent of the students in the Archery

The efforts of Youngistaan organisation in psycho-social rehabilitation of the students is appreciated.

Inspired children that they should treat this as a training period and not a punishment. They should inculcate good habits and skills while in the home.

Recommendations

Land may be identified and Building may be constructed for Juvenile Home at Mahabubabad

The UIADI may provide necessary assistance to the Juvenile welfare Department and may help in tracing the address of the children by making their aadhar data accessible through the Biometric of the children.

Juvenile Home for Girls-Nimboliadda, Kacheguda

The efforts of the administration in making the institution a homely atmosphere with psychological counselling and social support is appreciated.

The Hon'ble member lauded the classical dance skills and fine arts skills of the children and has expressed satisfaction over the accommodation and food being provided to the students along with the training facilities.

Recommendations

The Department may establish a computer lab with a minimum of 6-10 computers , a printer and a Xerox machine along with the instructors as computer skills became a minimum necessity for any placement like billing in supermarkets, petrol bunks where the inmates could later on secure placement.

The inmates may be provided training in self defense through karate/martial arts so that they could strongly defend themselves in adverse situations.

The barbed wire compound wall may be repaired on the backside for the safety and security of the inmates. Further the Kitchen garden in the backyard may be improved along with levelling of the ground.

The maggam work learnt by the inmates may be provided good marketing with new designs and may be supplied to the Government institutions.

The inmates may be given training in various trades as per their interests and capabilities by associating with any of the Industrial Training institutes and be provided placements.

Certain minimum infrastructure like the concrete benches may be made available in the premises for the convenience of parents or visitors for the wards/inmates. The management may explore the possibility of CSR/Donations in this regard.

A commercial washing machine may be made available in the Girls Home.



The Commission desires that the Secretary and Director should dispose off the grievances highlighted in a time bound manner. The NCST will continue to provide support in addressing these challenges.
