## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Smt. N. Geeta, W/o Prabhakar, Vikranti Theater, Pillar No. 1325, Mulgi No. - 5-2-28 & 29, Jam Bagh, Hyderabad, Telangana regarding demolition of her shop and caste abuse and harassment.

Smt. N. Geeta, W/o Prabhakar, residing at Vikranti Theater, Hyderabad, vide representation 21.10.2022 has alleged regarding harassment, threats, and extortion following the demolition of her fruit shop. She alleged local goons harassed her and sought revenge after she filed an FIR against them. She requested protection and permission to continue her business, which had allegedly been in her family for last 75 years.

- 2. The Commission issued a notice on 13.04.2023 to the Commissioner of Police, Hyderabad. In response, the Commissioner submitted a report dated 25.04.2023, stating no evidence was found to support the allegations, and the case was closed due to lack of evidence. The final report was submitted to the court, and the complainant was informed.
- NCST has convened a meeting on 03.01.2024, the following recommendations were made and minutes were forwarded to all concerned authorities on 23.1.2024 for furnishing the information within 30 days.
- Action for possession of the said property/shop from the petitioner has been taken by the Police as per Hon'ble Court order.
- Evidence/documents of ownership/gift deed in favour of petitioner or her family members in respect of said property/shop may be submitted by the petitioner to the Commission. The petitioner was earlier advised to approach the competent court in Appeal if such records are available with her.
- The Police authorities to take immediate action as per law on the complaint from the petitioner on her alleged caste base harassment.
  - 4. The O/o Commissioner of Police vide letter no. L&O/N/N4/0089/2023 dated 21.02.2024 has furnished the facts and comments and stated that enquiry was conducted to reopen the case but there is no incriminating evidence found. Hence, the case could not be reopened. The petitioner vide letter dated 9.12.2024 has informed that the accused and police department are threatening to kill her if she visited her Business place. Therefore, NCST has decided to discuss the issue with the authority and petitioner on 27.1.2025. Accordingly, a sitting notice was issued on 14.1.2025.
  - 5. During the sitting, the petitioner joined via mobile phone and Assistant Commissioner of Police, Sultan Bazar Division, Hyderabad and Inspector, Hyderabad were present on behalf of the Commissioner of Police, Hyderabad City, Telangana.
  - 6. The authority reiterated its earlier submissions and stated that the shop was demolished as per court orders and that there was no evidence of caste-based abuse. A copy of their letter dated 21.02.2024 along with other relevant papers was provided to the NCST. The petitioner claimed her right to the land and requested the Commission to intervene. The Commission inquired whether she possessed any documents to support her claim, and she stated that she would send them to the Commission.

 After hearing both sides, the Commission finds that the demolition was carried out by the authorities as per the court order. The petitioner may approach appropriate forum for redressal of grievance.
